Content somewhat similar to notes of interview with Ja'uan on 4/20/99 @MPIA p469 - handwriting of MacGillivray. A taped interview of Ja'uan (not apparently transcribed) was entered into BPD evidence records by MacGillivray at 9:28pm 4/23/99
