1	PROCEEDINGS
2	(Jury not present upon reconvening.)
3	THE CLERK: All rise. The Circuit Court for
4	Baltimore City, Part 9, is now in session, the Honorable
5	Wanda Keyes Heard presiding.
6	THE COURT: Please be seated. Good morning,
7	everyone.
8	MR. URICK: Good morning, Your Honor.
9	MS. MURPHY: Good morning.
10	MS. GUTIERREZ: Good morning, Judge.
11	THE COURT: Are there any preliminaries,
12	anything we need to discuss? I can tell you that my
13	secretary is preparing a schedule for next week. It
14	appears that I have one case almost every day of next
15	week. In other words, one case on Tuesday, Wednesday,
16	Thursday and Friday, which means that we should be able
17	to get started around 10:00, 10:30, about this time each
18	day next week. She is also including the end time for
19	each day. It appears that there is Wednesday when I have
20	a moot court competition that is taking place in this
21	courtroom at 5:00. So we would have to end at 4:30, a
22	quarter of 5:00, and she is indicating those end times.
23	So we will have that for you and we will have it for the
24	jury as well.
25	Anything else?

- 1 MR. URICK: There are two matters this morning,
- 2 Your Honor.
- THE COURT: Yes.
- 4 MR. URICK: To follow up when we left off last
- 5 night on Ms. I indicated I might want to come in
- 6 and revisit.
- 7 THE COURT: Yes.
- B MR. URICK: I'm not going to, but I want to
- 9 make the record clear that we object to the court's
- 10 ruling, so we preserve our right to appeal. I would just
- 11 like the record to reflect that we broke at 5:30 last
- 12 night. I attempted to research the law, however, when I
- 13 went to our library which is in this building. This
- 14 building closes at 7:00. I didn't have more than a half
- 15 hour to do that. I'm not conceding the point. We are
- 16 still opposed and object to the court's ruling. I just
- 17 wanted the record to reflect that.
- 18 THE COURT: Yes.
- 19 MR. URICK: I would point out that the statute
- 20 indicates that there is a waiver if the client introduces
- 21 the client's mental condition as an element of the
- 22 defense. We reserve the right to revisit this in
- 23 rebuttal.
- 24 THE COURT: In rebuttal, yes.
- 25 MR. URICK: Yes, you know, if he --

THE COURT: Opens the door to that himself. 1 MR. URICK: Yes. 2 THE COURT: Yes. 3 MR. URICK: So that's all I want to say on that 4 The second thing is, we still will need to voir 5 dire Juror Number Four or Alternate Number Four on Mr. Wilds. 7 THE COURT: I was going to suggest we do that at the luncheon recess if that's all right. It's the 9 alternate. Is that witness going to testify this 10 morning? 11 MR. URICK: It's possible. 12 THE COURT: All right. Then we will take a 13 break before that witness testifies to make sure that we 14 voir dire the juror before that witness testifies. 15 MR. URICK: All right. 16 THE COURT: In other words, in terms of how far 17 we go this morning, if it's after lunch, we will have 18 already spoken to Alternate Number Four because we will 19 do it at the lunch break. If it's before lunch, we will 20 send them to stretch their legs while we talk to 21 Alternate Number Four. 22 Is that acceptable to the defense? 23 MS. GUTIERREZ: That's acceptable, Your Honor. 24

THE COURT: Okay.

1	MB. GOTTERMED. I have one other matter i
2	brought to your clerk's attention, and I appreciate the
3	assistance your office gave in regard to a case that was
4	set this morning before Judge Ward.
5	THE COURT: Postponement court at 11:30.
6	MS. GUTIERREZ: That's the message I got, and I
7	frankly don't understand why I have to be there since
8	it's a misdemeanor case and it's already been postponed
9	and has a new date, but that was the message, the fax
10	message that I got from Judge Ward.
11	THE COURT: We'll break at 11:30 and allow you
12	to go down and see Judge Mitchell. A few minutes before,
13	I'll have my staff call down. Ms. can you call
14	down to Judge Mitchell at about 11:15 and let him know
15	that I'm sending Ms. Gutierrez downstairs, and there will
16	be a request from this court that he try to handle
17	whatever that matter is so that she can return.
18	Actually, that might be a good time to voir dire Juror
19	Number Four after you get back.
20	In any event, I don't have any appointments at
21	lunch today, no bench conferences, no bench meetings, so
22	we should be able to move along today. I'm going to ask
23	if there are any other preliminary matters. If not, I'll
24	bring the jury out.

- 2 around.
- 3 (Brief pause.)
- THE COURT: Who is the witness that you are
- going to be calling once the jury is assembled?
- 6 MS. MURPHY: Ms. Inez She is right
- 7 outside. I can go and get her.
- THE COURT: Yes, why don't you have her come in
- 9 and have a seat in the witness box until the jury °
- 10 arrives.
- 11 MS. MURPHY: Okay.
- MR. URICK: Could we get the court's laser
- 13 pointer at this time?
- 14 THE COURT: You may borrow the court's laser
- 15 pointer again.
- 16 MR. URICK: Thank you. We appreciate that,
- 17 Your Honor.
- 18 (Brief pause.)
- 19 (The jury returned to the courtroom.)
- THE COURT: Please be seated as you reach your
- 21 respective seats. Good morning, ladies and gentlemen.
- THE JURY: Good morning.
- THE COURT: Once again, you are back in Part 9.
- We are ready to resume this trial. The State is going to
- 25 be calling its next witness as soon as Ms. Murphy gets

3	MS. MURPHY: Thank you, Your Honor. At this
4	time, the State would call Ms.
5	THE COURT: Ms. I need you to stand,
6	please, face Mr. who will render the oath to you.
7	I need you to raise your right hand, Ms.
8	INEZ
9	a witness produced on call of the State, having first
10	been duly sworn according to law, was examined and
11	testified as follows:
12	THE CLERK: You may be seated. Please keep
13	your voice up. State your name and your address for the
14	record.
15	THE COURT: And your name is?
16	THE WITNESS: My name is Inez
17	THE COURT: And your work address?
18	THE WITNESS: 1801 Woodlawn Drive, Woodlawn
19	High School.
20	THE COURT: Thank you very much. You may
21	proceed.
22	MS. MURPHY: Thank you, Your Honor.
23	DIRECT EXAMINATION
24	BY MS. MURPHY:
25	Q Ms. what is your occupation

- 1 A I'm a teacher, and I'm also an athletic
- 2 trainer:
- 3 Q And how long have you been doing that?
- 4 A Ten years.
- 5 Q Have you been at Woodlawn High School all of
- 6 those ten years?
- 7 A At Woodlawn High School ten years. I have
- 8 taught in Baltimore County more than ten years, but at
- 9 Woodlawn High School for ten years.
- 10 Q What sort of classes do you teach?
- 11 A I teach SAT, which is scholastic aptitude
- testing, preparation for the SAT test itself.
- Q What do your duties involve as an athletic
- 14 trainer?
- 15 A My athletic duties include treatment of all
- athletes' injuries, and treatment prevention for
- 17 athletes.
- 18 Q Do you know the victim in this case, Ms. Hae
- 19 Min Lee?
- 20 A Yes, I do. Yes, I did.
- Q How long have you known her?
- 22 A Since her ninth grade year.
- 23 Q Can you please describe your relationship with
- 24 Ms. Lee?
- 25 A We were friends.

- 1 Q And how did you get to know her?
- A I met her, her ninth grade year, when she came to Woodlawn looking for the field hockey coach, Ms.
- , which wasn't at the first practice on time.
- 5 Q And your relationship progressed from there?
- 6 A Yes.
- 7 Q Would you describe Ms. Lee as a scholar
- 8 athlete?
- 9 A Yes, I would.
- 10 Q What does that term mean?
- 11 A It means that you have played a sport for more 12 than a year and you have lettered in that sport and your 13 grade point average is, according to Baltimore County, at
- a certain level which is at least a 3.0 or better.
- Q When you say lettered in a sport, what do you mean by that?
- 17 A When you letter in a sport, you play the sport
- for a complete year. Then at the end of the season we
- 19 have what we call an athletic award banquet. We award
- 20 the student their letter. They actually get a letter --
- it's a "W" for our school, it's a "W" for Woodlawn -- and
- they get like a pin. Whatever sport you are playing, you
- get a pin for that particular sport.
- Q What sport of athletics did Ms. Lee participate
- 25 in?

- She played two sports. She played field hockey A 1 and lacrosse, girls lacrosse. 2 And would you say that she excelled in those 0 3 sports? Yes, she excelled because she had made all-5 county and all-metro. 6 At the time of her disappearance, had she 7 received any special recognition as a star athlete? 8 Yes, she had. The Baltimore County School 9 Board had come out, the Athletic Department, had come out 10 to tape her for this particular award. Whenever the 11 student has excelled and met all the qualifications for 12 13 Baltimore County, then they do a taping session which is aired on the Baltimore County Educational Network. And 14 they came out that particular day to tape her in her 15 uniform, and at a later point they get like a gold medal 16 and other certificates and awards from Baltimore County. 17 Do you also know the defendant, Adnan Syed? 0 18 Yes, I do. A 19 How long have you known him? 20 0 A At least since his tenth grade year. 21 Did at some point you become aware of a 22 0 relationship between Ms. Lee and Mr. Syed? 23

Yes, I did.

Can you describe that?

- 1 A It was a real friendly relationship.
- 2 Q Did either of them confide in you about their
- 3 relationship?
- 4 A On numerous occasions.
- 5 Q Were there any problems you were aware of?
- A Yes, there were.
- 7 Q Can you describe that?
- 8 A I knew because they had told me that their
- 9 families were unhappy with their relationship.
- 10 Q Did they elaborate as to why?
- 11 A They were not allowed to be together, and
- 12 basically what I was told was because of religious
- 13 reasons.
- 14 Q Did you also become aware at some point they
- 15 broke up --
- 16 A Yes.
- 17 Q -- for good?
- 18 A Supposedly.
- 19 Q Were you aware as to whether Ms. Lee was
- involved in any other relationships at that time?
- 21 A Yes.
- 22 O Do you recall approximately when that was?
- 23 A It was right after she got her job at Lens
- 24 Crafters at Owings Mills Mall.
- Q Okay. Did the defendant ever talk to you about

- 1 his feelings for her after she began seeing this other
- 2 person?
- A He just told me that it was over with, that
- 4 they were friends.
- 5 Q Did you recognize Ms. Lee's car?
- 6 A Would I recognize it?
- 7 Q Have you ever seen it?
- 8 A I have been in it.
- 9 MS. MURPHY: Okay. May I approach the witness,
- 10 Your Honor?
- 11 THE COURT: Yes.
- BY MS. MURPHY:
- 13 Q I show you what is in evidence as State's
- 14 Exhibit 12, and I will ask you to look at the two bottom
- 15 photographs.
- 16 A Okay.
- 17 Q Do you recognize that vehicle?
- 18 A Yes.
- 19 O Whose vehicle is it?
- 20 A It's Hae's car.
- 21 O And this is the car that you personally have
- 22 been in?
- 23 A Yes, I was.
- O Have you ever observed the defendant, Mr. Syed,
- 25 in her car?

- 1 A Yes, I have.
- 2 Q And to your knowledge, did he ever drive that
- 3 car?
- 4 A Yes.
- 5 Q So that wasn't an unusual occurrence?
- 6 A No.
- 7 Q To your knowledge, was Mr. Syed on the track
- 8 team at school?
- 9 A Yes, he was.
- 10 Q And did you have occasion to observe the
- 11 students who participated on the track team?
- 12 A Yes.
- 13 . Q How is it that you saw them?
- 14 A I would see them when they came either to get
- my keys to open up their team room because Mr.
- 16 wouldn't allow the kids to take his keys, and I had keys
- 17 to all the team rooms. I would see him when he came to
- 18 practice because most of the time he would come by and
- 19 talk to me, or I would see him because we have a
- 20 concession stand in the gym lobby also and I would see
- 21 him when he would come and purchase things from the
- 22 concession stand.
- 23 Q What time would track practice generally occur?
- 24 A Track practice would start after study hall,
- and study hall started from 2:15 to 3:00, and they had to

be at practice at least by 3:30. 1 Did you have any sense as to the defendant's 2 attendance at track practice? 3 MS. GUTIERREZ: Objection. THE COURT: Sustained. 5 BY MS. MURPHY: 6 Are you aware, Ms. , if the defendant 7 consistently went to track practice? 8 MS. GUTIERREZ: Objection. 9 THE COURT: Overruled. 10 THE WITNESS: There were times that he didn't 11 come. 12 BY MS. MURPHY: 13 What would happen if he didn't go to track 14 15 practice? Unlike other sports --A 16 MS. GUTIERREZ: Objection. 17 THE COURT: Sustained. Can you ask the witness 18 or determine a foundation basis of knowledge for this 19 20 information. She has not indicated any relationship to the track team or training or practice or anything 21 related to that. 22 MS. MURPHY: Thank you, Your Honor. 23 BY MS. MURPHY: 24 , were you actively involved with the 25 Q

- 1 track athletes?
- 2 A I was involved with all athletes at Woodlawn
- 3 High School in the capacity that I am the athletic
- 4 trainer for the entire Athletic Department.
- Q And how would that relate specifically to the
- 6 track athletes? What would you do with them?
- 7 A I have athletes on the track team that have
- 8 shin splints, and I have to do regular treatments for
- 9 them. I have athletes that have pulled muscles. I
- 10 usually check by to see whether or not there is an
- 11 athlete that needs any type of treatment. We have
- 12 training tables on both sides. There is a training table
- on the girls' side and there is a training table on the
- 14 boys' side. So anyone who wants treatment during that
- day, I will check. Then I will check by all the team
- 16 rooms and make sure they are locked because we had a lot
- 17 of theft going on. So I will make sure, and I have to
- 18 lock the team rooms up every day and make sure the locker
- 19 rooms are clear.
- 20 Q So is it fair to say that you were involved one
- on one with most all athletes including the track
- 22 athletes at Woodlawn High School?
- 23 A I think I can tell you every athlete that I
- 24 have seen because a lot of times kids come in and try to
- get in the gym after school, and I would tell them you

- are not an athlete, you need to leave.
- 2 Q Now, in some sports, is it true there were
- 3 ramifications if you missed practices?
- 4 A Some sports.
- 5 Q Is that true for track?
- A No. If it was basketball and you missed a
- 7 practice, you didn't play or either you didn't start.
- 8 Q How many students participated on the track
- 9 team?
- 10 A Depending on the season, if it's cross-country,
- 11 you may have maybe twenty. Cross-country is the long
- distance running, and a lot of kids don't get involved in
- the long distance running. If it's indoor track, that's
- 14 a different sport. There are more activities involved in
- indoor track and you have more events. So you would have
- anywhere from forty-five to sixty kids. It's the same
- 17 thing with outdoor track but not cross-country.
- MS. MURPHY: Your Honor, at this time I would
- 19 like to ask Ms. to step down from the stand and
- 20 come around to the map. I would like her to identify the
- 21 location of Woodlawn High School.
- THE COURT: Yes, she may do that.
- MS. MURPHY: And, Ms. , if you could
- 24 stand to this side so the jurors may see.
- THE WITNESS: (Indicating.)

1	BI MD. MORFHI.
2	Q I have got a sticker here with the letter "W"
3	standing for Woodlawn High School. If you could study
4	the map and then place that sticker at the location of
5	the high school.
6	A (Indicating.)
7	MS. MURPHY: Thank you. You may return to the
8	witness stand. Your Honor, if I may place a piece of
9	tape over that sticker
10	THE COURT: Yes, you may.
11	MS. MURPHY: to permanently affix it.
12	(Indicating.) Thank you.
13	BY MS. MURPHY:
14	Q Ms. , do you recall the date of Ms. Lee's
15	disappearance?
16	A The date? It was the same day that she was
17	being taped for the Baltimore County Scholar Athlete
L8	award.
L9	Q Did you see her that day?
0 2	A Yes, I saw her that day because she came to my
21	classroom, and I was in the middle of teaching, and she
22	needed to get her uniform in order to be taped for the
3	show, which she was supposed to get the day before, and
4	she came to my classroom and I had to give her my school
5	keys to go unlock the room to get her uniform out.

Q Do you recall what Ms. Lee was wearing on that 1 day? 2 A little short black skirt, light colored 3 blouse, and some real high black heels. 4 Okay. Did she have anything on her legs? 5 She had some nylon stockings, but they weren't 6 colored stockings, they were just clear stockings. 7 MS. MURPHY: May I approach the witness, Your 8 Honor? 9 THE COURT: Yes, you may. 10 BY MS. MURPHY: 11 Now, Ms. , I apologize for asking you to 12 Q do this, but I'm going to ask you to examine a State's 13 exhibit that is in evidence. Do you recognize the 14 articles of clothing? 15 A Yes. 16 Were those the same clothes that Ms. Lee was 17 Q wearing --18 19 A Yes. -- the day she disappeared? 20 0 21 A Yes. 22 THE COURT: Can we have the exhibit number of the item that you showed? 23

MS. MURPHY: Yes, Your Honor. That's State's

- 1 THE COURT: For identification purposes, or is
- 2 it in evidence?
- MS. MURPHY: I'm sorry. State's Exhibit 11,
- 4 which is in evidence.
- 5 THE COURT: All right. Very well.
- BY MS. MURPHY:
- 7 Q Did you see her later in that day?
- 8 A Yes.
- 9 Q Tell us what happened then?
- 10 A She was also a manager for the wrestling team,
- and she had done that several years, and she was real
- good at the scoring and she traveled with the wrestling
- team. That particular day she came up real quickly to
- 14 the concession stand and got a few items and told me she
- 15 would pay for them later and said she had to get to her
- 16 cousin to pick up her cousin from, I think it was middle
- school or elementary school, one of the two. But she
- 18 said it wasn't that far and that she would be back. And
- 19 I kept reminding her what time the bus was leaving
- 20 because the bus had to go to Chesapeake because it was a
- 21 tri-meet and they had to get there on time.
- 22 Q About what time of day was this?
- 23 A It was about 2:15, 2:20.
- 24 Q And where physically in the school did this
- 25 happen?

- 1 A In the gym lobby, and that's right in front of
- the gym. It's inside the gym but it's right in front.
- 3 O And this was a concession area?
- 4 A Concession stand.
- 5 Q Did Ms. Lee wait in line at the concession
- 6 stand before she spoke to you?
- 7 A No.
- 8 Q How do you know that?
- 9 A Because she went right back there and got it
- 10 like she usually does, and then she usually comes back
- and pays you when she gets back. She was always in a
- 12 hurry.
- Q What time would she have to be back to go to
- 14 the wrestling meet?
- 15 A The team was leaving that day at 5:00. They
- had a 6:30 meet. And she said, I'll be back before 5:00.
- 17 Q And how is it that you are certain she didn't
- 18 come back?
- 19 A I know she didn't come back because I had to
- 20 end up going with the track team to Chesapeake to score
- 21 the game.
- 22 Q Was that the track team or the wrestling team?
- 23 A I mean the wrestling team.
- Q Did you speak to the defendant after Ms. Lee's
- 25 disappearance?

- 1 A Yes.
- 2 Q What, if anything, did he indicate to you about
- 3 their relationship around the time she disappeared?
- 4 A After she had already been found? I don't know
- 5 which time.
- 6 Q At any point.
- 7 MS. GUTIERREZ: Objection.
- 8 THE COURT: One moment. May I see counsel at
- 9 the bench.
- 10 (Counsel and the defendant approached the bench
- and the following ensued:)
- 12 THE COURT: The basis of your objection.
- MS. GUTIERREZ: The broadness of it, adding at
- 14 any time. You know, I don't know what this witness is
- going to say or any particular time that it's related to.
- 16 THE COURT: And you all have me at a distinct
- 17 disadvantage because I don't know what the witness is
- 18 going to say. I don't know if this witness testified the
- 19 last time.
- MS. MURPHY: She did.
- 21 THE COURT: You all might have an idea but I
- 22 have no idea what she is going to say.
- MS. GUTIERREZ: Yes.
- 24 THE COURT: And are these statements general
- 25 statements that had been previously disclosed to the

- defense through the previous testimony or --
- MS. MURPHY: Yes.
- THE COURT: Okay. Well, again, you see, I'm at
- a disadvantage. I have no way of knowing what it is that
- 5 the --
- 6 MS. MURPHY: Yes. What the witness will --
- 7 THE COURT: You don't have to comment.
- 8 MS. MURPHY: Okay.
- 9 THE COURT: I'm just saying, as long as you
- 10 focus the witness so that we know what timeframe you are
- 11 asking.
- MS. MURPHY: Okay.
- 13 THE COURT: If there are several statements,
- that you focus the statement like before, right after,
- 15 you know, or before she disappeared.
- MS. MURPHY: Okay. I'll ask her the timeframe.
- 17 THE COURT: Okay.
- 18 MS. MURPHY: I'll just ask her when she had a
- 19 conversation before I ask her what it actually entailed.
- 20 THE COURT: Why don't we ask her how many times
- 21 have you had a conversation, when was the first
- 22 conversation, and then she can tell you when was the
- 23 second conversation.
- MS. MURPHY: Okay.
- THE COURT: That way Ms. Gutierrez, should she

- 1 have objection, the timeframe, we will know which
- timeframe you are referring to before the witness even
- 3 testifies. And, again, if you could direct her in that
- 4 way so that at least I have an idea of what timeframe,
- 5 and Ms. Gutierrez, if she has an objection, I can rule on
- 6 that objection at that time.
- 7 MS. MURPHY: Okay.
- 8 THE COURT: I would appreciate that.
- 9 MS. MURPHY: Okay.
- 10 THE COURT: Thank you.
- 11 (Counsel and the defendant returned to the
- trial tables and the following ensued:)
- THE COURT: All right. You can re-ask your
- last question. I'm going to ask Ms. , if you will
- listen closely to the question and answer the question
- 16 only.
- MS. MURPHY: Thank you, Your Honor.
- 18 BY MS. MURPHY:
- 19 Q Did there come a point where you spoke with the
- 20 defendant about Ms. Lee after her disappearance?
- 21 A Yes.
- Q On how many occasions did you speak with him?
- 23 A At least twice.
- 24 O And when was the first time?
- 25 A The first time was when I asked him if he was

- 1 going to her memorial.
- 2 Q What did he tell you?
- 3 A No.
- Q Did he explain that?
- 5 A Because of the different religion.
- 6 Q And the second time, do you recall when that
- 7 was?
- 8 A It was on a Friday. I had just come from
- 9 picking up my daughter, and it was right in front of the
- 10 loop of the school.
- 11 Q Do you recall the time period, what month?
- 12 A First of all, let me tell you what time. It
- had to be after 3:00 because I pick my daughter up at
- that time, at a quarter of 3:00, and usually to get back
- from John Paul to Woodlawn, it takes me about ten
- minutes. So it would have to have been like probably
- 17 around 3:00.
- Q Okay. Do you recall, was this before or after
- 19 Ms. Lee's body had been discovered?
- 20 A After.
- 21 Q What did your conversation with the defendant
- 22 entail at that point?
- 23 A I pulled around the loop and, as usual, he
- 24 would come up to the car if he saw me, and he spoke to

- 7 picking up your daughter, you, on a daily basis, had an
- 8 awful lot of things to do --
- 9 A That is correct.
- 10 Q -- that concerned a large number of students?
- 11 A That is correct.
- 12 Q And concerned usually more than one sport at a
- 13 time?
- 14 A That is correct.
- 15 Q It was not unusual at Woodlawn for Woodlawn to
- 16 have several different sporting events both at the school
- 17 and elsewhere on the same day?
- 18 A That is correct.
- 19 Q And you had to be concerned with all of the
- 20 students participating in all of those events?
- 21 A That is correct.
- 22 Q And you had to sort of man and make sure that
- 23 things like the lockers were secure?
- 24 A That is correct.
- 25 Q And that anyone who didn't belong there,

- student or adult, something was done about it?
- 2 A Yes. That's why I had a walkie-talkie.
- Q Okay. And on that walkie-talkie, you
- 4 communicated with other adults?
- 5 A Right.
- 6 Q Members that worked for the school?
- 7 A That is correct.
- 8 Q And also shared with you the responsibility for
- 9 ensuring the safety of the athletes?

All 8 So what you did was the right way to handle that. right. 9 THE WITNESS: Okay. 10 THE COURT: Very well. You may continue. 11 BY MS. GUTIERREZ: 12 You knew Adnan Syed as one of the athletes that 13 you were responsible for also; did you not? 14 Yes, I did. A 15 And that was back in January of 1999, his 16 senior year; was it not? 17 Yes. 18 A And you had known him then at least from the 19 0 time he was a sophomore? 20 At least. 21 A And he was also a scholar athlete; was he not? 22 I have to say that I couldn't consider him, 23 A according to Baltimore County, as a scholar athlete. 24

- 5 Hae Min Lee and Adnan Syed; were you not?
- A Yes.
- 7 Q And you were aware that that relationship was
- 8 more than just friends at school?
- 9 A Yes.
- 10 Q You were aware that they were girlfriend and
- 11 boyfriend with each other; were you not?
- 12 A Yes.
- 2 And you became aware of that, when they became
- girlfriend and boyfriend, the previous spring around the
- time of the junior prom?
- 16 A Yes.
- 17 Q And you were aware of some of the ups and downs
- of their relationship; were you not?
- 19 A Yes.
- 20 You were aware before they even began to talk
- 21 to you that there were difficulties, that neither family
- really knew or approved of the relationship; were you
- 23 not?
- A Well, no, not before they talked to me about
- 25 it.

- 1 Q And they talked to you because you were very
- open with them as a teacher; were you not?
- 3 A Yes.
- 4 Q It's not unusual for students to come and bring
- 5 any issues or problems they had to you and ask for your
- 6 input; was it?
- 7 A No, it wasn't.
- 8 Q And there was nothing unusual about Hae and/or
- 9 Adnan doing that?
- 10 A No.
- 11 Q And they both actually came to you at different
- times; did they not?
- 13 A Yes.
- 14 Q And everytime you spoke to them, they were
- essentially, although they had different perspectives,
- bringing the same information to your attention; were
- 17 they not?
- 18 A Basically, yes.
- 19 Q And what they said about their relationship and
- their feelings about each other was consistent as between
- one and the other; was it not?
- 22 A Can you re-ask that?
- 23 Q What Hae said was consistent with what Adnan
- 24 said; was it not?

- 1 Q And what Adnan said was consistent with what
- 2 Hae said; was it not?

- 4 Q These young people were agonized over their
- families' reaction to the relationship; were they not?
- 6 A Yes.
- 7 Q And they were agonized that the religious
- 8 differences might tear them apart?
- 9 A Yes.
- 10 Q And there were times when they took breaks from
- 11 each other; was there not?
- 12 A (No response.)
- 13 Q From the relationship?
- 14 A Yes.
- 15 Q And you were aware that even throughout those
- 16 times, from the beginning of their relationship, that
- 17 they were friendly and loving to each other?
- 18 A Yes.
- 19 Q And you were aware from each of them by the
- fall of 1998, that they were continuing in the
- 21 relationship?
- 22 A Yes.
- 23 O Notwithstanding their parents' objections?
- 24 A Right.
- Q And notwithstanding their religious

- 1 differences?
- 2 A Correct.
- 3 Q And that they continued to be very loving to
- 4 each other?
- 5 A Yes.
- 6 Q You were aware of the incident that occurred at
- 7 the homecoming dance; were you not?
- 8 A Yes.
- 9 Q And that dance occurred, I believe, in late
- 10 October --
- 11 A Yes.
- 12 Q -- of 1998?
- 13 A That is correct.
- Q And that the incident involved the two of them
- and Adnan Syed's parents?
- 16 A That is correct.
- 17 Q And you were aware that subsequent to
- 18 homecoming, that the two of them continued to see each
- 19 other?
- 20 A (No response.)
- Q Are you not?
- THE COURT: She's thinking.
- 23 THE WITNESS: I'm thinking. I'm trying to
- think, because after the homecoming dance, I didn't
- 25 basically see them together.

1	BY MS. GUTIERREZ:
2	Q So you weren't aware of whether or not they
3	were still together after that time?
4	A No.
5	Q So as far as you were concerned, your two
6	friends could have split then and never been girlfriend
7	and boyfriend after that?
8	A Boyfriend and girlfriend, yes; but still
9	friends, yes, because they would tell me that they were
10	still talking to each other but they weren't allowed to
11	be seen together.
12	Q To be seen together
13	A Right.
14	Q or to pursue the relationship that they both
15	appeared to you, from your conversations with each of
16	them, to be committed to?
17	A Right.
18	Q And so it could very well be possible that they
19	didn't consider themselves girlfriend and boyfriend as
20	far back as late October, 1998?
21	A No, not then.
22	Q Not then?
23	A Because they were still seeing each other then
24	because we had football games and I remember Hae actually

going to the football games and standing on the sideline

- 1 at the football games.

- 2 A That is correct.
- 3 Q You were aware that other Muslim students also,
- 4 like Adnan, violated their religious tenents and dated
- 5 others; were you not?
- A No, I don't know of any other Muslims that
- 7 dated.
- 8 Q So your experience was that the Muslims at
- 9 school didn't date?
- 10 A I don't know that they don't date, but I'm
- 11 saying that I know that they hang with other kids at
- 12 school but there are certain kids that when I talk to
- them, that are Muslims, that just point blank come up to
- me and say I wish I could do this but I can't, you know.
- 15 Q Because of their religion?
- 16 A Right.
- 17 Q And you respected that; did you not?
- 18 A Yes.
- 19 O And other students at the school seemed to
- 20 respect their Muslim colleagues and their decisions; did
- 21 they not?
- 22 A Yes.
- 23 O And no other interfaith couple at that time
- 24 sought your confidence as a teacher and an adult about
- 25 their relationship; did they?

- 1 A No.
- 2 Q Okay. Now, you used the words that they both
- 3 confided in you. Do you recall that?
- 4 A They both talked to me.
- Okay. But you chose the word confided; did you
- 6 not?
- 7 A I don't remember.
- 8 Q Okay. Well, they spoke freely to you; didn't
- 9 they?
- 10 A That I remember you saying, yes.
- 11 Q They spoke to you, each of them, about what was
- in their heart for the other; did they not?
- 13 A Yes.
- 14 Q And they sought you out; did they not?
- 15 A Yes.
- 16 Q And each of them appeared to know that the
- 17 other also sought you out; did they not?
- 18 A They knew it.
- 19 Q They knew it, right?
- 20 A Uh-huh.
- 21 Q And they didn't appear to be hiding things from
- 22 you; did they?
- 23 A No.
- Q And, in fact, you got the distinct sense that
- 25 they shared with you things that neither of them could

- share with others?
- A A lot of things.
- 3 Q And that they couldn't share those things with
- 4 their own families?
- 5 A That is correct.
- 6 Q And that they were pained by the secrecy?
- 7 A I don't know if they were pained by it, but I
- 8 know that they told me things that happened or supposedly
- 9 happened that nobody else should know.
- 10 Q Well, they were not happy that their families
- were unhappy with them about this relationship; were
- 12 they?
- 13 A I think Adnan talked to me about his mother and
- 14 father not being happy about it. But Hae, on the other
- 15 hand, she was different, and if Hae --
- 16 Q Hae wasn't a Muslim, right?
- 17 A No. And if she wanted to do something, she did
- 18 it.
- 19 O She did whatever she wanted to do?
- 20 A Yes.
- 21 Q She was a pretty determined young woman; was
- 22 she not?
- 23 A Yes.
- 24 Q She was not somebody that you would call shy or
- 25 laid back?

- 1 A No.
- 2 Q Hae spoke her mind?
- 3 A Yes.
- 4 Q Did she not?
- 5 A Yes.
- 6 Q To whomever?
- 7 A Yes.
- 8 Q If Hae felt something was going on, she would
- go up to that person; would she not?
- 10 A I think so.
- 11 Q If she felt strongly about it?
- 12 A I think so.
- Q And Hae felt very strongly about people's
- 14 conduct; did she not?
- 15 A I don't know if I can answer that about
- 16 conduct.
- 17 Q Was Hae a person you would describe as a
- 18 particularly popular girl?
- 19 A Very popular.
- Q And was she well-liked?
- 21 A Very well-liked.
- Q Was she resented by anyone?
- 23 A Not that I know of.
- Q Was she thought to be stuck up at all?
- 25 A Not at all.

- 1 Q And was she aware of her popularity?
- 2 A Yes.
- 3 Q And did she take it seriously?
- 4 A I don't know how --
- 5 Q Did she appear to have any --
- 6 MS. MURPHY: Objection.
- 7 THE COURT: Objection to the previous question
- 8 or the next question?
- 9 MS. MURPHY: No. I believe that she was still
- 10 speaking when she --
- MS. GUTIERREZ: She answered the question, I
- 12 don't know.
- 13 THE COURT: Were you finished with the
- 14 question?
- 15 (No response.)
- 16 THE COURT: Were you finished answering Ms.
- 17 Gutierrez's question?
- 18 THE WITNESS: I'm saying I didn't know. What I
- 19 was saying, I don't know that she objected to being
- 20 popular, and I was going to say because that just was her
- and the way that she behaved, and she just did stuff for
- 22 people all the time. So I don't know if she objected to
- 23 it. I think she liked it.
- 24 THE COURT: Okay. When you are --
- 25 MS. GUTIERREZ: I will ask another question,

- 1 Judge.
- THE COURT: One moment, please. When you are
- asked to respond to a question, what we need you to do is
- 4 respond to the best of your knowledge and belief. If
- 5 it's something you are guessing at --
- THE WITNESS: I said that I didn't know.
- THE COURT: And that's all that we need you to
- 8 say, is I don't know.
- 9 THE WITNESS: Okay.
- 10 THE COURT: That's a fine response.
- 11 THE WITNESS: Okay.
- THE COURT: If you know the answer, then you
- indicate the answer.
- 14 THE WITNESS: Uh-huh.
- 15 THE COURT: If you can't answer the question,
- 16 you can say I can't answer the question.
- 17 THE WITNESS: Okay.
- THE COURT: Now, with regard to your objection,
- 19 it's overruled. The answer was, I don't know.
- MS. GUTIERREZ: Thank you, Your Honor.
- THE COURT: Your next question, Ms. Gutierrez.
- BY MS.GUTIERREZ:
- Q Ms. you just said that Hae dissed other
- 24 people; did you not?
- 25 A I didn't say she dissed them.

- Q Well, then I misheard. What is it you said?
- What did she do to other people?
- 3 A (No response.)
- 4 Q Oh, did stuff with other people.
- 5 A Yes.
- 6 Q Okay. Then was she fairly interactive with
- 7 other students?
- 8 A Yes.
- 9 Q And other students appeared to freely interact
- 10 with her?
- 11 A Yes.
- 12 Q Were you aware of a Woodlawn student by the
- 13 name of Jay Wilds?
- 14 A Yes.
- Q And did you know him from his matriculation at
- 16 school?
- 17 A As far as him graduating from Woodlawn High
- 18 School and going to Woodlawn High School, yes.
- 19 Q Okay. And was he a scholar to your knowledge?
- 20 A No, he was not a scholar athlete.
- 21 0 Was he an athlete?
- 22 A Yes, he was.
- 23 Q In what sports did he play?
- A He played boys lacrosse and soccer.
- Q Okay. And was he someone you considered to be

a friend? 1 A No. Did you socialize with him outside the school? Q 3 A No. Q And was Jay Wilds ever in your observance appearing to be a close friend of Hae Min Lee? 6 I have never seen them together. A And have you seen him up at school since the 8 time that he graduated? 9 Yes. A 10 Often? 11 0 No. 12 Did you ever inquire as to what his purpose was 13 for being up there? 14 Well, I didn't have to ask him because --15 A You knew. 16 Q 17 A I knew. And that was because his girlfriend was up 18 there? 19 That is correct. A 20 And that is Stephanie? 21 Q A Yes. 22 And was Stephanie a scholar? 23 Q Yes, she was. A 24

And was she an athlete?

25

- 1 A Yes, she was.
- 2 Q And when you would see Jay Wilds up there,
- 3 where would he be?
- A Well, if he came to the building before 2:15, I
- 5 didn't let him in.
- 6 O Because he wouldn't have been allowed?
- 7 A No.
- 8 Q Because he was not a student?
- 9 A No.
- 10 Q And he had no legitimate purpose --
- 11 A No.
- 12 Q -- for being in or on the grounds, correct?
- 13 A That is correct.
- 14 Q But after school closed, sometimes he would be
- 15 around?
- 16 A That is correct.
- 17 O Did you know him to drive Stephanie's car?
- 18 A Yes.
- 19 Q And did you know him to borrow other students'
- 20 cars?
- 21 A The only person's car I have seen him drive is
- 22 Stephanie's car --
- 23 O Did you --
- 24 A -- and his.
- 25 Q Did you see him interact with other students?

- 1 A Yes.
- 2 Q And did you ever see him interact with Hae Min
- 3 Lee?
- 4 A No.
- 5 Q And how long were you aware that Stephanie and
- Jay were girlfriend and boyfriend?
- 7 A For a long time.
- 8 Q And were you aware that that relationship began
- 9 before either of them attended Woodlawn?
- 10 A No.
- 11 Q And were you aware that there was also parental
- disapproval of that relationship by Stephanie's parents?
- MS. MURPHY: Objection. I think we are way
- 14 beyond the scope, Your Honor.
- THE COURT: Sustained.
- 16 BY MS. GUTIERREZ:
- 17 Q You answered the prosecutor's question about
- did you become aware when they broke up for good, and you
- used the term supposedly. Do you recall that?
- 20 A Yes.
- 21 Q And that was because you had seen them break up
- 22 before, correct?
- 23 A Not break up. I have seen them after they told
- me that they weren't supposed to see each other anymore.
- 25 Q But they still continued to see each other,

- 1 right?
- 2 A Yes.
- 3 Q And they still continued to be girlfriend and
- 4 boyfriend?
- 5 A They told me they were friends.
- 6 Q Okay. So there had become a time when, as far
- 7 as what you knew, they were not girlfriend and boyfriend
- 8 but they were still friends?
- 9 A Correct.
- 10 Q And they both verbally articulated a commitment
- 11 to that?
- 12 A Can you restate that again, please?
- Q Did both of them verbally, did they both state
- 14 that, that they were committed to being friends with each
- 15 other?
- 16 A That they were friends.
- 17 Q And from your observations, did they appear to
- 18 be friends --
- 19 A Yes.
- 20 Q -- after that time period?
- 21 A Yes.
- 22 Q And Adnan participated as a member of the track
- 23 team; did he not?
- 24 A Yes, he did.
- Q And the track team, that was the indoor track

- 1 team; was it not?
- 2 A That is correct.
- 3 Q And that did not include cross-country, did it?
- 4 A No.
- 5 Q And the indoor track team, was the next period
- of meets, including practices and meets, in the middle of
- 7 January, 1999?
- 8 A Yes.
- 9 O And at the same time track was going on,
- 10 wrestling was going on, correct?
- 11 A That is correct.
- 12 Q That's the athletic team that Hae Lee managed;
- is that correct?
- 14 A That is correct.
- Q And in addition to track and wrestling,
- 16 basketball was going on; was it not?
- 17 A Yes, it was.
- 18 Q Basketball for girls?
- 19 A Yes.
- 20 Q And basketball for boys?
- 21 A Yes.
- 22 Q Teams that traveled and played other schools,
- 23 correct?
- 24 A Yes.
- Q And basketball programs that pitted students

- 1 against each other?
- 2 A I don't understand that question.
- 3 Q I'll ask another question. And in addition to
- 4 track and wrestling and girl's and boy's basketball, were
- there other athletic teams that were in season?
- 6 A Yes.
- 7 O And what were those?
- 8 A Bowling, that's it.
- 9 Q And how many athlete students would you
- 10 estimate were involved in the middle of January, on
- January 13th, in all of those various programs?
- 12 A Bowling, I think probably around twenty-six,
- but they wouldn't have been involved in any part of the
- building because bowling goes to a bowling lane on
- 15 Security Boulevard to bowl. So they wouldn't even be
- 16 involved.
- 17 Q Okay. But I didn't ask you that. I just need
- 18 to know the numbers.
- 19 A I'm just trying to say numbers. Then the next
- 20 sport would have been boy's basketball, fifteen, and
- 21 that's varsity. Boys JV basketball, twenty-two. Girls
- varsity basketball, about twenty. Girls JV basketball,
- 23 about fifteen.
- Q Okay. And, in fact, on that particular day,
- January 13th, was also a girl's varsity meet; was there

- 1 not?
- 2 A Basketball.
- 3 O Basketball?
- 4 A Yes.
- 5 Q And that meet took place somewhere else; did it
- 6 not?
- 7 A That is correct.
- 8 Q But when there is a meet elsewhere, the team
- 9 goes as a group; does it not?
- 10 A That is correct.
- 11 Q And they leave the school as a group, correct?
- 12 A That is correct, most times.
- 13 Q Most times.
- 14 A Unless there is permission to travel from their
- 15 parents --
- 16 Q Separately.
- 17 A -- separately.
- 18 Q Okay. But at most meets, the team travels
- 19 together; do they not?
- 20 A That is correct.
- 21 O And that means that the team has to meet at the
- school, congregate together, and then they get on a bus?
- 23 A That is correct.
- 24 O And you, of course, are in charge of
- supervising all of that; are you not?

- 1 A Basically, I usually go on the bus before the
- team leaves. We do a head count to see if everybody is
- 3 there that should be on the bus, and then, you know, wish
- 4 them good luck.
- 5 Q That's part of your supervision, isn't it?
- 6 A Yes.
- 7 Q And that meet, that varsity girl's meet, took
- 8 place where, if you recall?
- 9 A It wasn't a meet. That's a basketball game.
- 10 Q Oh, I'm sorry.
- 11 A A meet is a track meet.
- 12 Q Okay. A game.
- 13 A Yes.
- 14 Q A meet is for track and a game is for
- 15 basketball?
- 16 A Uh-huh.
- Q Okay. And where did that take place?
- 18 A I don't remember.
- 19 Q Okay. But you are aware and you do remember
- that there was one, right?
- 21 A I don't remember.
- 22 Q Okay. Now, the wrestling meet you said was
- elsewhere and, therefore, the team would have gotten
- 24 together and organized to leave. Is it a wrestling team?
- 25 A A wrestling team.

- 1 Q Okay. Would have gotten together and
- 2 congregated before leaving together at about 5:00?
- 3 A That is correct.
- 4 Q Because the meet was scheduled to be at 6:30?
- 5 A Because the match would have been scheduled for
- 6 7:30.
- 7 Q The match. Okay. And that's because of where
- 8 the Chesapeake location was --
- 9 A That is correct.
- 10 Q -- and the distance from Woodlawn to there?
- 11 A Forty-five minutes.
- 12 Q And it was not unusual to have athletic events
- 13 scheduled that late, was it?
- 14 A No.
- 15 Q Okay. And part of Hae Min Lee's
- 16 responsibilities would have been to accompany the
- 17 wrestling team to their --
- 18 A Match.
- 19 Q -- match; is that correct?
- 20 A That is correct.
- 21 Q And she ordinarily did that; did she not?
- 22 A That is correct.
- 23 Q But on that day, you have told us she never got
- 24 back in time, correct?
- 25 A That is correct.

- 1 Q And that it was a surprise to you?
- 2 A Yes.
- Q And that you had to alter your plans to
- 4 accompany the wrestling team to their match forty-five
- 5 minutes away?
- 6 A That is correct.
- 7 Q There were times when Hae Min Lee didn't
- accompany the wresting team; were there not?
- 9 A Not that I am aware of because I never had to
- 10 travel before.
- 11 Q Okay. So it was unusual that she didn't come
- 12 back?
- 13 A That is correct.
- Q Hae Min Lee, in your knowledge, was a young
- girl to her word; was she not?
- 16 A That is correct.
- 17 Q If she said she was going to be there, she was
- 18 going to be there?
- 19 A That is correct.
- 20 Q And you expected that from her?
- 21 A I expected it.
- 22 Q Now, you became aware shortly after that match
- or the next day that she had also not shown up at places
- 24 her family expected her to show up?
- 25 A That is correct.

- 1 Q And you became aware that there was a missing
- 2 person's report filed in this case; did you not?
- 3 A Not shortly after, not directly right after
- 4 that.
- 5 Q But at some point you became aware; did you
- 6 not?
- 7 A At some point, yes.
- 8 Q And you knew that the Baltimore County police
- 9 were looking for Hae Min Lee; were they not?
- 10 A Yes, I was.
- 11 Q And you were aware that everyone at Woodlawn
- 12 knew that Hae Min Lee was missing?
- 13 A Yes.
- Q And that it was the subject of talk from every
- 15 corner; was it not?
- 16 A Yes.
- 17 Q Teachers?
- 18 A Yes.
- 19 Q Students?
- 20 A Yes.
- 21 O Employees of the school?
- 22 A I don't know about that.
- Q Well, you were aware that everybody was trying
- 24 to remember the last they knew of Hae?
- 25 A I was aware of her teachers knowing and being

- aware that she was missing, and student friends of her's
- were aware that she was missing.
- 3 Q And you became aware that Adnan was one of
- 4 those students who became aware --
- 5 A Yes.
- 6 Q -- that she was missing?
- 7 A Yes.
- 8 Q And during the course of time after her
- 9 disappearance, you were spoken to by the police; were you
- 10 not?
- 11 A Yes, I was.
- 12 Q You were spoken to by them on the phone?
- 13 A No.
- 14 Q In person?
- 15 A In person.
- Q And you were spoken to by them in person by
- 17 Detective O'Shea who was in charge of the investigation?
- 18 A He was one of the detectives.
- 19 Q And do you recall speaking to Detective O'Shea
- 20 on February the 1st?
- 21 A I don't remember the date.
- 22 Q Do you recall Detective O'Shea coming to your
- 23 home?
- A To my home?
- Q Yes.

- 1 A I don't remember him coming to my house.
- 2 O He came to the school?
- A Oh, he came to the school.
- 4 Q And you were aware that he was coming; were you
- 5 not?
- A I was told after he got there that he wanted to
- 7 see me.
- 8 Q Okay. Because you had information about Hae
- 9 Lee's activities on the last day that she had been seen,
- 10 correct?
- 11 A That is correct.
- 12 Q And Detective O'Shea took notes of his
- 13 conversation with you; did he not?
- 14 A Yes.
- 15 Q You didn't object to that, did you?
- 16 A No, I didn't.
- 17 Q You knew that he was seeking the most accurate
- information that he could gain from persons who may have
- been the last to see Hae Min Lee, correct?
- 20 A Yes.
- 21 Q And would it be fair to say, Ms. \_\_\_\_, that
- your memory of the events of January 13th were far
- clearer and better back on February 1st, 1999 than they
- 24 are today?
- 25 A Probably.

- 1 Q And there is nothing unusual about that; is
- 2 there?
- 3 A I don't think so.
- 4 Q Back then, would you agree that it would be
- fair to say that you had thought about that day, the
- 6 13th, before Detective O'Shea spoke with you on February
- 7 the 1st?
- 8 A I don't understand that question.
- 9 Q Well, when you first heard Hae was missing, did
- you not try to recall the events of the 13th?
- 11 A No. When I heard she was missing, I think, and
- I even said to the detectives, I wonder where this child
- is now.
- 14 Q Okay. And so you did think about it; did you
- 15 not?
- 16 A I guess.
- 17 Q And you thought about it on more than one
- 18 occasion; did you not?
- 19 A Yes.
- 20 Q You became aware of others, particularly
- 21 teachers, who were also concerned with her because they
- spoke about it in that interim period; did they not?
- 23 A Yes.
- Q Now, on February 1st, 1999, do you recall
- 25 telling Detective O'Shea about your last conversation

- 1 with Hae Min Lee?
- 2 A I probably told him about her coming and
- 3 getting my keys and going to get her uniform.
- Q So the answer to my question is yes?
- 5 A I think so, yes.
- 6 Q You told him?
- 7 A Yes.
- 8 Q And that would have been normal; would it have
- 9 not?
- 10 A Yes.
- 11 Q If he had asked you questions about Hae Min Lee
- and that day, you would have readily answered him; would
- 13 you have not?
- 14 A Yes.
- 15 Q You weren't hiding anything from him, were you?
- 16 A No.
- 17 Q There was nothing that happened that you didn't
- 18 want him to know?
- 19 A No.
- 20 Q You wanted to help in any way with information
- that might lead them to discover where she was?
- 22 A Yes.
- 23 Q The thought that you said crossed your mind was
- I wonder where that child is; isn't that correct?
- 25 A Yes.

- 1 Q And do you recall that what you told Detective
- O'Shea, that on the 13th of January, 1999, that Hae was
- 3 upset?
- 4 A Yes.
- A And do you recall telling Detective O'Shea that
- 6 Hae told you that she, meaning Hae, was having problems
- 7 at home?
- 8 A Yes.
- 9 Q And do you recall telling Detective O'Shea that
- 10 Hae also said she wanted to contact her father in
- 11 California?
- 12 A Yes, in San Diego.
- 13 0 Is that correct?
- 14 A Uh-huh.
- Q And Hae was upset that day; was she not?
- 16 A I don't know if it was that day, but I said the
- 17 last thing I remember, I mean conversation-wise with her,
- was that she was upset and she talked about getting in
- 19 touch with her father in San Diego if he was in the
- 20 country.
- 21 Q And this was on February 1st that you told
- 22 Detective O'Shea these things?
- 23 A I don't know what day it was I talked to him.
- Q Well, whatever day, did you talk to him more
- 25 than once?

- 1 A Yes.
- 2 O At the school?
- 3 A Yes.
- Q On one day that you spoke to him at the school,
- 5 you did tell him those things?
- 6 A Yes.
- 7 Q That Hae was upset?
- 8 A Yes.
- 9 Q That she was having problems at home?
- 10 A Yes.
- 11 Q And that she wanted to contact her father in
- 12 California?
- 13 A That is correct.
- 14 Q And would you be surprised if Detective O'Shea
- wrote down that that conversation occurred on February
- 16 the 1st?
- 17 A Whatever day, I wouldn't remember.
- 18 Q Okay. And you would expect Detective O'Shea,
- based on your interaction with him, to have accurately
- 20 recorded his conversation with you; would you have not?
- 21 A Yes.
- 22 Q He appeared genuinely interested in obtaining
- any information that might help him locate Hae Min Lee?
- 24 A Yes.
- Q And you, of course, have already told us your

- interest was in being as forthcoming as you could?
- 2 A Yes.
- 3 Q And would you be surprised if Detective O'Shea
- 4 wrote down that those things -- her being upset, her
- 5 having problems at home, and her wanting to contact her
- father -- took place in the conversation that you had
- 7 with her on 1/13/99?
- 8 A I don't remember.
- 9 Q You don't?
- 10 A No.
- 11 Q Okay.
- 12 A But I know at some point I did tell him that.
- 13 Q Okay. And you would have expected Detective
- 14 O'Shea to have accurately recorded his notes of that
- 15 conversation; would you not?
- 16 A I don't know. I guess he would, yes.
- 17 Q I mean, you wouldn't have expected Detective
- 18 O'Shea to change the dates about what you said?
- 19 A No.
- MS. MURPHY: Objection.
- 21 THE COURT: Overruled.
- BY MS. GUTIERREZ:
- 23 Q And/or to mess up and say you said something
- 24 happened on some other date?
- 25 A All I remember is that I told him that these

- 1 events had happened, and I don't know exactly what date
- because I talked to him a lot of times and I don't
- 3 remember exactly when I told him.
- Q Okay. And Hae did tell you those things,
- 5 correct?
- 6 A That is correct.
- 7 Q And you observed her to be upset at the time of
- 8 telling?
- 9 A She didn't appear upset. She just told me that
- she was going to do these things.
- 11 Q Well, do you recall telling Detective O'Shea
- 12 that Hae was upset?
- 13 A She said there are things that are upsetting
- me, I need to get in touch with my father, and I'm having
- 15 problems.
- 16 Q And the problems were at home?
- 17 A Yes.
- 18 Q And you believed her when she told you she was
- 19 upset, didn't you?
- 20 A Yes, I believed her.
- 21 O You didn't disbelieve her and think she was
- 22 making it up?
- 23 A No.
- Q And it wasn't a surprise to hear that she was
- 25 having problems at home, was it?

- 1 A No.
- 2 Q It was a period of time where she was having
- problems at home; was it not?
- 4 A Yes.
- 5 Q All right. Now, you also told Detective O'Shea
- all about Hae Lee's athletic endeavors; did you not?
- 7 A Yes, I think I did.
- 8 Q And that included telling him that Hae was a
- 9 manager for the wrestling team; did it not?
- 10 A Yes.
- 11 Q And you, of course, told him about the
- 12 wrestling match that was scheduled for later that evening
- 13 that she didn't show up to?
- 14 A I don't know if I told him or not.
- Q Well, her failure to appear for a scheduled
- wrestling match you have told us was an unusual event?
- 17 A What I'm saying is, I don't remember exactly
- the conversation I had with him totally detail-wise. I
- 19 know that at some points I told him about her not showing
- 20 up. I do remember that.
- 21 Q My question was, you have already told us -- is
- 22 it still true -- that her failure to show up for a
- wrestling match as the manager was an unusual event?
- 24 A That was unusual.
- Q And it caused you to alter your plans?

Yes. A 1 MS. MURPHY: Objection. 2 THE COURT: Overruled. 3 BY MS. GUTIERREZ: 4 And the fact that it was unusual and that it 5 caused you to alter your plans is one of the things that 6 7 would have committed that fact to your memory; was it not? 8 A Yes. 9 Do you recall telling Detective O'Shea that Hae 10 told you on that day, the 13th, 1999, that she would not 11 be at the match? 12 13 No. 14 And would you be surprised to know that Detective O'Shea, who interviewed you and took notes 15 during that interview, on more than one occasion wrote in 16 his report that on that day, February 1st, that you said 17 to him that Hae told you that she would not be at the 18 match on the 13th? 19 I don't know. 20 Q You didn't lie to Detective O'Shea, did you? 21 A No, I did not. 22 And you didn't attempt to conceal anything to Q 23

- 1 Q Woodlawn High School is situated and faces
- 2 Woodlawn Drive; does it not?
- 3 A Yes, it does.
- 4 Q At one end of the school from its situation,
- 5 Woodlawn Drive crosses Security Boulevard; does it not?
- 6 A Woodlawn Drive does.
- 7 Q And at the other end, going the other
- 8 direction, Woodlawn Drive crosses a road by the name of
- 9 Dogwood Road; does it not?
- 10 A That is correct.
- 11 Q And Dogwood Road is a sort of meandering just
- 12 two lane road; is it not?
- 13 A Yes.
- 14 Q And Dogwood Road continues -- let me get my
- directions right -- continues eastward; does it not?
- 16 A Yes.
- 17 Q And it continues until the time it enters
- 18 Baltimore City; does it not?
- 19 A Dogwood Road?
- 20 Q Yes.
- 21 A I don't know if it goes -- I'm trying to think.
- 22 I think it changes into something else.
- 23 Q It changes into Franklintown Road; does it not?
- 24 A Okay.
- MS. MURPHY: Objection.

- 1 THE COURT: Overruled. Do you know what the
- 2 name of the street is?
- 3 THE WITNESS: No, I don't know. I know it
- 4 changes.
- 5 THE COURT: Okay. Then what you have to say is
- 6 I don't know. Okay?
- 7 THE WITNESS: Okay.
- 8 THE COURT: So the objection is sustained. As
- 9 the witness has indicated, she does not know what the
- 10 street turn into.
- BY MS. GUTIERREZ:
- 12 Q Are you familiar with a road named Franklintown
- 13 Road?
- 14 A No.
- Q And are you familiar with a section of Dogwood
- 16 Road that contains several bars, one of which is the Mill
- 17 Rays Tavern?
- 18 A No.
- 19 Q Are you aware of the bars that are on Dogwood
- 20 Road directly below Woodlawn Drive?
- 21 A No. I know there are probably some over there
- 22 but I mean I don't usually go that way.
- 23 THE COURT: Ms. Gutierrez, I'm going to ask
- 24 that we pause here. I note that it's 11:30. I know my
- 25 clock is about five minutes fast, which may be a good

- thing, at least in light of that I think there is another
- 2 court where you must go.
- 3 MS. GUTIERREZ: Yes.
- THE COURT: So we are just going to take a
- 5 break. It will be a good time to allow the jurors to
- 6 stretch their legs a little bit. I'm going to ask the
- 7 deputy sheriff if she will kindly walk the jurors around
- 8 to the jury room and see that they are secured in that
- 9 location. I believe the door may be locked. Mr.

- 23 (The jury was excused from the courtroom.)
- 24 THE COURT: Okay. You can come around. There
- is a microphone down there. I just need you to get to a

microphone, that's all. 1 ALTERNATE NUMBER FOUR: Okay. 2 THE COURT: You may go to lunch as well. 3 must advise you that you are a witness sequestered. You 4 5 may not discuss your testimony with anyone. You can stretch your legs for about fifteen minutes, and then 6 I'll ask that you have a seat on the bench outside and we 7 will let you know when we are going to resume. 8 THE WITNESS: Okay. (The witness was excused from the courtroom.) 10 MR. URICK: Excuse me. Are you asking her to 11 come back before we break for lunch? 12 THE COURT: Yes. She is going to sit outside 13 for a few minutes. 14 MR. URICK: Okay. 15 THE COURT: Alternate Number Four, I just 16 wanted to just touch base with you. 6	THE COURT: When you say that you might feel
7	uncomfortable, I mean is there something about your
8	knowledge of
9	ALTERNATE JUROR NUMBER FOUR: Well, I mean
10	there is like well, I know a T
11	two scenarios. So like if I happen to see a T
12	outside, you know, that would you know, I might make
13	this connection.
14	THE COURT: The association.
15	ALTERNATE JUROR NUMBER FOUR: The association.
16	THE COURT: Assuming you made the association
17	that T , in your view, is related to Jay Wilds,
18	you wouldn't know what that relationship is. Is that
19	what you are telling me?
20	ALTERNATE JUROR NUMBER FOUR: I might
21	THE COURT: You wouldn't know if that is his
22	brother or his son or
23	ALTERNATE JUROR NUMBER FOUR: I might infer
24	there is some relationship without knowing what it is.
25	THE COURT: Okay.

1	ALTERNATE JUROR NUMBER FOUR: I do not remember
2	having I am not familiar with the name Jay Wilds. I
3	do not remember meeting a Jay Wilds. I do know
4	superficially, socially, a T
5	THE COURT: Okay. Again, I would ask, the fact
6	that you know this T let's say he does show
7	up and he is sitting in the audience, and so then now you
8	can make the association that Jay Wilds has some
9	relationship to T would that in any way

- 9 you know?
- 10 A I know we traveled towards the city on Route 40
- and some of the back streets. We cut north and south, up
- and down roads. He pulled into like this alcove in the
- back of a whole lot of apartments. He parked the car and
- came back to his vehicle. At that time, I told him just
- 15 flat out to take me home. He started driving me home.
- 16 We went up 40.
- 17 Q Now, if you would at this point, look at line
- 18 nine and also line eight?
- 19 A Yes.
- 20 Q Do you recognize that number?
- 21 A Yes.
- Q And it's the same number on both lines?
- 23 A Yes.
- Q Whose number is that?
- 25 A Ms. 's pager number.

- 1 Q Please read it for the record.
- 2 A
- Now, when you say pager, is this a voice mail
- 4 pager or a number punched in pager?
- 5 A I believe that one also had voice mail.
- 6 Q Okay. Now, on line nine, please look at the
- 7 time.
- 8 A 8:04 p.m.
- 9 Q And the length of the call?
- 10 A Thirty-two seconds.
- 11 Q And the one above it, please read the time.
- 12 A 8:05, and the length was thirteen seconds.
- MR. URICK: With the court's permission, at
- this time I'm going to write "pager" on both
- 15 lines eight and nine.
- 16 THE COURT: Any objection?
- MS. GUTIERREZ: No, Your Honor.
- 18 THE COURT: You may do so, line number eight
- 19 and line number nine.
- 20 MR. URICK: (Indicating.) Pardon me. I
- inadvertently started to write "residence". I had to
- 22 black it out. I'm going to write "pager" above the
- 23 blacked out section.
- 24 BY MR. URICK:
- Q Do you remember those pages?

- 1 A Yes, sir.
- 2 Q Why were you paging Ms.
- 3 A I wanted her to retrieve me from, I believe at
- first it was a mall, and then the second time it was my
- 5 house.
- 6 Q And do you remember where you were when you
- 7 made those pages?
- 8 A Going up 40 in Adnan's car.
- 9 Q What if anything was he saying at this time?
- 10 A He didn't say too much. He just said it kind
- of makes him feel better and then again it doesn't.
- Q What did he mean by that?
- 13 A Killing Hae.
- Q As you are driving up Route 40, where did you
- 15 go?
- 16 A He stopped at Westview Mall. He drove around
- 17 to the back of the mall towards the banking end. He was
- 18 flipping through her wallet. I don't think he was really
- 19 looking for money or anything like that.
- 20 When you say "her wallet", what do you mean?
- 21 A Hae's wallet.
- Q When had you first seen that?
- 23 A That was the first time I had seen it.
- Q Where did he get it?
- 25 A I believe he brought it back with the

- 1 possessions he brought out of her car at the parking lot.
- Q He is flipping through it. What if anything
- 3 does he do?
- 4 A He just shows me her prom picture and just
- 5 pssst. That's all he says. He doesn't say anything, he
- 6 just goes pssst, and he chucks the rest of the stuff into
- 7 the trash can, into the dumpster.
- 8 Q What if anything did you do next?
- 9 A I told him to pull over out back of Value, City.
- I took both of my shovels. They were mine but I just
- 11 chucked them, threw them.
- 12 Q What if anything did you do next?
- 13 A I believe I told him to take me around to the
- 14 front of the mall. I think I might have paged Jenn from
- there again but I can't quite remember. I believe he
- 16 took me home. I may have paged Jenn from the front of
- the mall but I believe he took me home. I got to my
- house and I was in my house for maybe five minutes. I
- 19 instantaneously changed all my clothes and put them all
- 20 in a bag.
- Q Why did you put them in a bag?
- 22 A Just because I figured they would have dirt on
- them or whatever, you know what I mean, from what I had
- 24 done.
- 25 Q And what significance would dirt have had?

A It would have tied me in. It could have placed
me wherever. I didn't want to have anything to do with
it.

O What if anything happened next?

A My mother kept trying to talk to me. I was real agitated. I just left real quick. I got into Jenn's car and I told Jenn to drive back around to the shovels. I was getting real panicky like, paranoid. She drives back around to the shovels. I wipe both the shovels down with the sleeve of my coat. I take the coat that I wipe them down with and I put it in the bag.

Q Why did you wipe down the shovels?

A Fingerprints, or at least mine. And we both, we got back in the car and we drive to Super Fresh. We went to go buy a pack of blunts, Mexicale Slims. While she is in the store buying the blunts, I get out of the car, I go around back and I throw my clothes in the dumpster. We leave there and I believe we go to Ms.

That night when I had first got in the car, I told Jenn, just because of who I am and how people see me, that if anything happens to me, for her to be the one person, even if I'm in jail, to know that I didn't kill Hae Min Lee. That was the first thing I told her when I saw her that night.

What if anything else did you tell her? 0 1 Nothing else. I didn't tell her anything like 2 details or nothing like that. I just told her that. I 3 don't think she really believed me at first. That was 4 all that was spoke of it for the rest of the evening. 5 Now, you went back to Ms. 6 's. What did you do after you left there? 7 I went home and went to sleep. 8 9 Did there come a time when you visited your girlfriend that night? 10 Yes. 11 A MS. GUTIERREZ: Objection, leading. 12 13 THE COURT: Overruled. THE WITNESS: There was. I believe it was 14 right after Jenn had picked me up. I had taken her her 15 birthday presents, but I didn't stay. It was her 16 17 birthday but I was real rattled and shaken. I don't know, I just kind of gave her her stuff. I didn't even 18 come up to the house. I stood on the curb, gave her her 19 stuff and a hug, and I left. 20 BY MR. URICK: 21 About what time did you get home that night? 22 Q 23 A Eleven something. Now, after that night, did you ever speak to 24

the defendant again?

- 1 A Once.
- Q When did that occur?
- 3 A Maybe once or twice. The first occasion was
- about two days later. I had my girlfriend's car. I had
- driven it to work. Mr. Syed had given her a lift to my
- 6 house and as she was getting out of the car, he said to
- 7 me, you know me and Stephanie are friends, you know we go
- 8 to school together, and he just smiled. I kind of took
- 9 that as if he could hurt her whenever he felt like it.
- 10 And I get back in the house and Stephanie had told me
- 11 that they had just come from College Park.
- MS. GUTIERREZ: Objection.
- 13 THE COURT: Sustained as to what Stephanie told
- 14 him.
- 15 THE WITNESS: I'm sorry.
- 16 BY MR. URICK:
- 17 Q Did you have any further contact with the
- 18 defendant after that?
- 19 A I believe once more. He came into my store
- 20 where I worked.
- Q What type of store was that?
- 22 A An adult video store.
- 23 Q And what did you do there?
- 24 A I was a clerk. I rented videos and handed out
- 25 quarters.

- 1 Q About how long did you work there?
- A About two months.
- 3 Q Why did you work in a pornography store?
- A It was the graveyard shift, 11:00 to 7:00.
- 5 Q Why did you work there?
- A That was the time I worked. I worked at F&M
- during the day, and it was the graveyard shift. I got
- 8 there and got paid \$7.50 to sit behind the counter.
- 9 Q He came to that store?
- 10 A Yes.
- 11 Q Do you remember about when this occurred?
- 12 A No, all I remember is that he was in his EMT
- uniform and his partner was with him. All he asked me
- 14 was what the cops asked me. That was it.
- 15 Q Had the police spoken to you at that time?
- A No, they hadn't talked to me yet. He asked me
- if the cops asked me anything and that was it.
- 18 Q Did you tell Stephanie anything?
- 19 A No.
- 20 Q Did you warn her?
- 21 A Yes, that was one thing, she didn't question
- me. I just told her I didn't want her around him, I
- 23 didn't want her to go anywhere with him, I didn't want
- 24 her to be alone with him.
- 25 Q Why?

1	A	Because he could harm her.
2		(Brief pause.)
3		(State's Exhibit No. 35
4		was marked for purposes
5		of identification.)
6		MR. URICK: If I may approach the witness at
7	this time	e, I'm going to show him what has been marked for
8	identifi	cation as State's Exhibit 35.
9		THE COURT: Yes, you may.
10		BY MR. URICK:
11	Q	Take a few moments and look at that, if you
12	would, p	lease, and examine each page.
13	A	Okay.
14		THE COURT: One moment.
15		(Brief pause.)
16		THE COURT: You may continue.
17		BY MR. URICK:
18	Q	Have you had a chance to examine the exhibit?
19	A	Yes.
20	Q	Can you identify that exhibit?
21	А	Yes.
22	Q	What is that exhibit?
23	A	It's the agreement I signed.
24	Q	And that's the plea agreement you entered into
25	when you	pled guilty to accessory in this murder?

1	A Yes.
2	Q And what is your understanding of how your
3	honesty affects this agreement?
4	A Well, if I tell any kind of lie, it voids it
5	and it's no good. It's a truth agreement, and that's
6	about it, a cap. As long as I tell the truth, I can only
7	get a certain amount of years.
8	MR. URICK: I would offer, as State's Exhibit
9	35, the witness' plea agreement.
10	THE COURT: Any objection?
11	MS. GUTIERREZ: No.
12	THE COURT: Let it be admitted.
13	(State's Exhibit No. 35,
14	previously marked for
15	identification, was
16	received in evidence.)
17	MR. URICK: May I have the court's indulgence
18	for just a moment?
19	THE COURT: Yes, you may.
20	(Brief pause.)
21	BY MR. URICK:
22	Q If you would, please, look at that exhibit
23	again. Do you see line seventeen?
24	A Yes.
25	Q Do you recognize that number?

	A No.
2	Q The times that you and the defendant were
3	riding around together, where was the cellphone?
4	A In his possession.
5	
6	A No, I did not.
7	Q Were you present when Hae Min Lee was killed?
8	A No, I was not.
9	Q Why didn't you just at anytime during the
10	course of the evening just drive or walk away?
11	A Fear, shock, those are my only two reasons.
12	Well, ignorance.
13	MR. URICK: Witness with the defense.
14	THE COURT: Witness with you, Ms. Gutierrez.
15	MS. GUTIERREZ: Thank you, Your Honor.
.16	CROSS-EXAMINATION
17	BY MS. GUTIERREZ:
18	Q First of all, Mr. Wilds, let's speak about this
19	plea agreement. I'm sorry, I thought you had it. Can I
20	have it, please. Thank you. State's Exhibit 35, which
21	is in evidence, you have reviewed that before today, have
22	you not?
23	A Yes, ma'am.
24	Q It's your signature that appears on each and
25	every page, does it not?

- 1 A Yes, ma'am.
- Q It's typewritten, is it not?
- 3 Yes, ma'am.
- 4 Q And on the last page, your lawyer's signature
- 5 appears, does it not?
- A Yes, ma'am.
- 7 Q Your signature appears?
- 8 A Yes, ma'am.
- 9 Q And Mr. Urick's signature appears; isn't that
- 10 correct?
- 11 A Yes, ma'am.
- 12 Q And all three of those signatures are dated
- 13 9/7/99, correct?
- 14 A Yes, ma'am.
- 15 Q Now, one of the things that you were asked and
- you answered this morning was about being in jail. Do
- 17 you remember that?
- 18 A No, ma'am, I do not.
- 19 Q You haven't been in jail on this offense, have
- 20 you?
- 21 A No, ma'am, I have not.
- Q Not before the 7th of September, 1999, right?
- A No, ma'am.
- 24 O And not after?
- 25 A No, ma'am.

- 1 Q And you are not in jail now, are you?
- 2 A No, ma'am.
- 3 Q And you really don't expect to be in jail, do
- 4 you?
- 5 A I cannot foresee that. I don't know what's
- 6 going to happen.
- 7 Q State's Exhibit 35 is titled "Agreement"; is it
- 8 not?
- 9 A Yes, ma'am.
- 10 Q And in that agreement, you agreed to plead
- quilty to the crime of an accessory after the fact,
- 12 correct?
- 13 A Yes, ma'am.
- 14 Q To the murder of Hae Min Lee, correct?
- 15 A Yes, ma'am.
- 16 Q In this agreement, every page of which you
- initialed, there is not a single word concerning the
- 18 facts of the crime that you agree to enter a guilty plea
- 19 on, correct?
- 20 A Yes, ma'am.
- Q Not a single word about the facts, correct?
- 22 A Pardon me.
- Q Not a single word about the facts.
- 24 A Of the case?
- Q Of the case.

- 1 A Yes, ma'am.
- 2 Q There is not a single word in here, right?
- 3 A (No response.)
- 4 Q Right?
- A I have answered that question, yes, ma'am.
- 6 Q So that's a yes?
- 7 A Yes, ma'am.
- 8 Q And there is not a single word about what it is
- 9 you are accused of doing, correct?
- 10 A Oh, no, there is a word of that.
- 11 Q And where is that? Would you look at that and
- show me where a single word of facts concerning what you
- are accused of doing appears, sir? Is it on page one?
- 14 A Oh, I'm sorry.
- MR. URICK: The State would ask that unless Ms.
- 16 Gutierrez is showing the witness an exhibit that she not
- 17 hover over him.
- THE COURT: I have no objection, Ms. Gutierrez,
- if you stand next to the witness. I have no problem with
- 20 that.
- MS. GUTLERREZ: Thank you.
- THE COURT: But I would ask that you lower your
- voice because I think that we all can hear you.
- MS. GUTIERREZ: Thank you, Judge.
- THE COURT: You may proceed.

2	Q	It's not on page one, is it?

17	Q	The day after you signed this agreement, you
18	appeared	before a judge, did you not?

20		MR. URICK: Objection.
21		BY MS. GUTIERREZ:
22	Q	And Mr. Urick was there, was he not?
23		THE COURT: Overruled as to this question.
24	3-	BY MS. GUTIERREZ:
25	Q	Mr. Urick was there, was he not?

- 1 A Yes, ma'am.
- 2 Q And your lawyer was there, was she not?
- 3 A Yes, ma'am.
- 4 Q And you raised your hand much like you raised
- 5 today to a court reporter and swore to tell the truth?
- A No, ma'am, I did not.
- 7 Q You did not?
- 8 A No, ma'am.
- 9 THE COURT: One moment. One moment, Ms.
- 10 Gutierrez. I'm going to ask the jury -- if we could just
- 11 stop for just one second, Ms. Gutierrez.
- MS. GUTIERREZ: Sure.
- 13 THE COURT: And I'm going to ask, please be
- 14 advised -- the lady who is in the hat, you may come back
- and have a seat. Come back and have a seat. What is
- 16 occurring right now is that there are a number of people
- that would like to observe this trial. I have absolutely
- 18 no objection to individuals coming in. However, if you
- 19 have been here for more than an hour and you are not a
- 20 family member, I'm going to ask that you go outside and
- 21 have a seat for an hour so that other individuals in the
- hall that would like to come in may do so.
- 23 When I say family member, I mean either that
- 24 you are a family member of the defense or a family member

You were not asked to swear to tell the truth. 17 Today you remember being asked to tell the truth? 18 Yes, ma'am. A 19 20 And you know what an oath is? A Yes, ma'am. 21 And you would have us believe that you know 22 what the truth is, would you not? 23 MR. URICK: Objection. 24

Sustained.

THE COURT:

1	BY MS. GUTIERREZ:
2	Q Now, Mr. Wilds, this is your lawyer?
3	A Pardon me.
4	Q This is your lawyer?
5	A Yes, ma'am.
6	MR. URICK: Objection.
7	THE COURT: Overruled.
8	BY MS. GUTIERREZ:
9	Q Okay. And that was the same lawyer that
10	appeared with you at that earlier occasion, correct?
11	A Yes, ma'am.
12	Q And you remember the day after when you
13	appeared in front of the Judge? It was in this very
14	building, was it not?
15	A I don't remember whether it was east or west
16	but, yes, here.
17	Q And you are familiar with the east and west
18	buildings, are you not?
19	A Yes.
20	MR. URICK: Objection.
21	THE COURT: Overruled.
22	BY MS. GUTIERREZ:
23	Q Okay. And on the day after you signed this
24	that you appeared in front of the judge, you were asked a
25	lot of questions, were you not?

1 A No, ma'am. You don't recall answering questions posed to 2 Q you directly by the judge? 3 Not a lot. 4 A Not a lot? 5 No, ma'am. 6 A MR. URICK: Objection. 7 THE COURT: Overruled. 8 BY MS. GUTIERREZ: 9 Whatever ones he asked you, you answered, did 10 Q you not? 11 A Yes, ma'am. 12 And your lawyer was right next to you, was she 13 Q 14 not? Yes, ma'am. - 6 Q Well, you know what I'm talking about when I am
- 7 saying facts about your involvement?
- 8 A Yes.

- you what an accessory after the fact is; has it not?
- 13 A Yes.

- THE COURT: And before she starts getting into
- anything other than the plea agreement, I would like to
- 6 have a chance to have you be prepared to sit for at least
- 7 the next hour to hour and a half because we are going to
- 8 go til 5:00 today. I think that was our agreement.
- 9 Ladies and gentlemen, do not discuss the
- 10 testimony that you have heard so far. Leave the notepads
- 11 face down.
- 12 Counsel, are you going to need them to refer to
- the handouts that they have?
- MS. GUTIERREZ: No, Judge.
- 15 THE COURT: All right. You can pass the
- handouts up to Mr. and if you need it back --
- MS. GUTIERREZ: Well, actually, Judge, that's
- 18 untrue, I will later.
- 19 THE COURT: All right.
- MS. GUTIERREZ: I'm not sure I can get to it
- 21 today, but I think I will.
- 22 THE COURT: All right. You can still pass it
- 23 up for right now. When you need it, we will have it
- 24 passed back to you. Ladies and gentlemen, please be
- advised that, as I said, you are not to discuss the

- testimony with anyone, not amongst yourselves or with
- 2 anyone else.
- Also, we will attempt to get the adjustment
- 4 made to the heater to try to cool it off in here a little
- 5 bit, and perhaps set up a fan. I take it you all are as
- 6 warm as I am.
- 7 THE JURY: Yes.
- 8 THE COURT: All right. Very well. We will do

- 9 THE COURT: Okay. Very well. Now, with regard
- 10 to my concern, I have no problem with spectators. This
- 11 is my courtroom. There is plenty of room for the
- 12 victim's family, the defendant's family and other
- 13 spectators to observe this case. But I need to advise
- 14 the spectators that if you have been here for more than
- 15 an hour and you are asked to step out in the hall, it is
- 16 because there is a family member that wishes to come in
- 17 and observe the trial. So I will ask, if you are a
- 18 spectator, that you do that. Then at sometime that I am
- 19 advised that there is a bigger courtroom available, then
- 20 we will move to a bigger courtroom. But until that
- 21 occurs, we will continue here.
- I also ask that if you have a coat or a jacket
- 23 on, that you hang that up because it's very warm in here,
- 24 and it also would make room for others to sit down. If
- 25 you have bundles, you can put them under you. There is

- 1 space. And I'm going to set up some fans during the
- 2 break so it can cool us off a little bit and maybe crack
- 3 the windows. Then I'll bring the jury back. And I want
- 4 everyone to know, we will try to make this as comfortable
- 5 for everyone as possible.
- I also advise you, those of you who are
- 7 spectators, please do not make it necessary for me to
- 8 tell a spectator, a non-family member, to leave for an
- 9 hour because I will do that if there is a family member
- in the hallway that would like to observe this trial.
- 11 Again, if you leave, it doesn't mean you are leaving
- 12 forever. It just means that for an hour or so, you will
- 13 sit in the hall. Then after an hour, you will be able to
- 14 come back in.
- 15 All right. I'm not going to go into any more
- 16 detail as to what I mean, I think everyone in this
- 17 courtroom understands exactly what I mean. We are all
- 18 adults. We are all mature adults. I would ask that you
- 19 honor my request. If I'm able to locate a larger
- 20 courtroom, I will do so.
- 21 Now, at this moment, this court stands in
- 22 recess for the next ten minutes.
- 23 MS. GUTIERREZ: Ten minutes?
- 24 THE COURT: Yes.
- 25 THE CLERK: All rise. This court stands in

1		recess for ten minutes.
2		(Brief recess.)
3		-000-
4		(Jury present upon reconvening.)
5		THE CLERK: All rise. This court now resumes
6	Ł	in session.
7		THE COURT: Please be seated. Counsel, ladies
8		and gentlemen, I did just speak to the Judge-In-Charge of
9		Criminal. There is not another courtroom availiable for
10		me. All the judges are working, and there are no
11		courtrooms. The one that is available will not hold a
12		panel of this size. So, therefore, we are going to be
13		here.
14		I'm going to ask once again that the witnesses
15		and spectators please mind the court's I'll say this
16		again mind the court's order that if you are in the
17		courtroom and you are not a relative of the victim or the
18		defendant, that you stay for an hour and then leave and
19		give someone in the hallway who may be a family member
20		the opportunity to come in and watch this case. If you
21		are asked by the sheriff to step out in the hallway and
22		you refuse, I will recess and you could find yourself in
23		contempt of this court's order because I have asked
24		nicely for you to cooperate.
25		I will also tell you that the exception to this

- 1 rule would be staff of Ms. Gutierrez and staff of Mr.
- 2 Urick and Ms. Murphy, and, in this case, the attorney for
- 3 Mr. Wilds. Okay. You may remain. Other than that and
- 4 the family, as I have indicated, those spectators at this
- 5 point that have not been in this courtroom for an hour
- 6 are welcome to remain.
- MR. URICK: May counsel approach?
- 8 THE COURT: Yes.
- 9 MS. BENAROYA: That would include me, Your
- 10 Honor, because this concerns a matter that involves me.
- MS. GUTIERREZ: Judge, I would object to that.
- 12 May we approach as counsel first?
- 13 THE COURT: Yes. Well, first of all, I'm going
- 14 to ask counsel to approach that are in this case. The
- other attorney that is present, you may have a seat, and
- 16 I'll see whether or not you are needed at the bench.
- 17 (Counsel and the defendant approached the bench
- and the following ensued:)
- 19 THE COURT: Okay. Please tell me what the
- 20 problem or issue is. Do you know what the problem or
- 21 issue is?
- MR. URICK: Ms. Benaroya informed us that Ms.
- 23 Gutierrez has issued a subpoena for her, and since there
- is a sequestration motion, she would have to stay out of
- 25 the courtroom, but she is the attorney for Mr. Wilds. So

- I wanted to bring that to the court's attention. She
- 2 might want to make a motion to quash.
- 3 THE COURT: Okay. And the purpose of the
- 4 service of the subpoena for the defense?
- 5 MS. GUTIERREZ: She may or may not become a
- 6 witness, but if she becomes a witness, it would not
- 7 involve anything regarding --
- 8 THE COURT: Anything her client is --
- 9 MS. GUTIERREZ: Right. It would involve other
- things that are not privileged certainly regarding her
- 11 client but would not concern, that would not be a
- violation of the sequestration order in regard to what,
- if anything, she would be asked, if she were called as a
- 14 witness subsequent to his testifying.
- THE COURT: So you are saying that you have no
- objection to her remaining in the courtroom --
- MS. GUTIERREZ: No, I don't.
- 18 THE COURT: -- during the course of Mr. Wilds'
- 19 testimony.
- MS. GUTIERREZ: Correct.
- 21 THE COURT: Okay. Is there any other problem?
- MS. MURPHY: Your Honor, there are two non-
- family members who the State feels need to be present in
- 24 the courtroom.
- THE COURT: Okay.

- MS. MURPHY: One is Doctor Kim. He is
- 2 providing interpretation for the family members who do
- 3 not speak English.
- 4 THE COURT: Okay.
- 5 MS. MURPHY: The other is Detonya . She
- is a representative from the Bereavement Center of the
- 7 State's Attorney's Office.
- 8 THE COURT: Okay.
- 9 MS. MURPHY: Both are here with the victim's
- 10 family but they are not immediate family members, and I
- would ask that they be allowed to stay in the courtroom.
- THE COURT: Okay.
- MS. GUTIERREZ: Well, Judge, I will note that
- 14 two or three of the benches only have three people on
- them, and three of the other benches have four people on
- 16 them, so that we should be able to accommodate two extra
- 17 people without any difficulty.
- 18 THE COURT: Okay.
- 19 MS. MURPHY: They are all seated. They are all
- 20 here.
- 21 THE COURT: All witnesses are now seated?
- 22 MS. MURPHY: No, the victim's family members
- and the two people that I just mentioned.

- 5 MS. GUTIERREZ: In the gray suit.
- 6 THE COURT: Sitting with the mother and I guess
- 7 the father of the victim.
- 8 SHERIFF: Okay.
- 9 THE COURT: He can remain.
- 10 SHERIFF: Okay.
- MS. MURPHY: Everyone else in that row is part
- of the victim's family.
- 13 THE COURT: Okay. Why don't we do it the other
- way around. Who in this courtroom is not either a family
- member of the defendant or a family member of the victim,
- and if you could just turn around and look around and
- 17 tell me who is not.
- 18 MS. MURPHY: Mr. Y his mother, and the
- 19 victim's grandfather are all seated in the back row.
- 20 THE COURT: That's not what I asked you, Ms.
- 21 Murphy.
- MS. MURPHY: Aside from them --
- 23 THE COURT: I'm asking you who in this
- 24 courtroom do you see that is not?
- MS. MURPHY: Your Honor, aside from those

- people and the two people I have identified, I don't know
- 2 who the rest of them are.
- THE COURT: Okay. Those are the people that
- 4 you now.
- 5 MS. MURPHY: Right.
- 6 THE COURT: Okay.
- 7 MS. MURPHY: There are five people that are
- 8 associated with the family of the victim.
- 9 THE COURT: Okay. Very well. What about to my
- 10 left on the front row behind Ms. Gutierrez' staff?
- MS. MURPHY: I believe they are not with the
- 12 victim's family.
- THE COURT: Ms. Gutierrez, do you know?
- MS. GUTIERREZ: I don't know who they are
- 15 except for the young white gentleman who drew my
- 16 attention at the break. He is a pre-law student from
- 17 Hopkins who is fulfilling a requirement to observe court
- 18 proceedings and he is covering this trial.
- THE COURT: Well, there are a whole lot of
- 20 other court proceedings in this building. That's why I
- can't get this trial moved to another courtroom.

1	Q Well, Mr. Wilds, you are aware that the
2	proceeding the following day didn't mean that you pled
3	guilty?
4	MR. URICK: Objection.
5	THE COURT: Sustained.
6	MS. GUTIERREZ: May we approach the bench?
7	THE COURT: Yes, you may approach the bench.
8	(Counsel and the defendant approached the benc
9	and the following ensued:)
10	MS. GUTIERREZ: Judge, I maintain that where
11	these questions go is to establish that, in fact, this
12	witness has not entered
13	THE COURT: You need to keep your voice down.
14	MS. GUTIERREZ: Oh, I'm sorry. This witness
15	has not entered a guilty plea.
16	THE COURT: I understand. The problem I'm
17	having with your question is, you are asking this witness
18	for a legal term of art. You and I know what a guilty
19	plea is.
20	MS. GUTIERREZ: Except that he answered the
21	question. Mr. Urick asked him that question, when you
22	pled guilty. I'm asking him a question in the exact same
23	phraseology.
24	THE COURT: Please keep your voice down.

MS. GUTIERREZ: He answered that question. He

- 1 understood it when Mr. Urick asked him. I'm asking him
- 2 for his understanding of it.
- THE COURT: One moment. One moment. Ms.
- 4 Murphy, are you going to be talking or is Mr. Urick going
- 5 to be talking?
- MS. MURPHY: I believe Mr. Urick will be
- 7 speaking, Your Honor.
- 8 THE COURT: Okay.
- 9 MS. MURPHY: I was conferring with him.
- 10 THE COURT: I understand that. Excuse me.
- 11 Ladies and gentlemen, I'm going to ask that you
- go back to the jury room. I'm going to ask that while
- you are there, that you not discuss the testimony, nor
- 14 discuss anything else. I'm going to ask that you leave
- 15 your notepads face down on your chair. I ask that you go
- 16 with Ms. at this time. Then at such time that I
- am able to bring you back, I will do so.
- 18 (The jury was excused from the courtroom.)
- 19 (Brief pause.)
- THE COURT: Mr. Wilds, I'm going to ask you to
- 21 step out in the hallway, please. Do not discuss your
- 22 testimony with anyone. I ask that you not have any
- 23 conversation with your attorney about this case without
- first asking me or letting me know in advance that you
- are requesting to talk with your attorney.

1	THE WITNESS: Yes, ma'am.
2	(Whereupon, the witness was excused from the
3	courtroom.)
4	THE COURT: Counsel, you can step back, please.
5	(Counsel and the defendant returned to the
6	trial tables and the following ensued:)
7	THE COURT: Now, first and foremost, if at
8	anytime during the time you are at a bench conference you
9	are of the opinion that either counsel is speaking too
10	loudly, address that concern to me. I do not appreciate
11	your making remarks on the record that you believe that
12	she is talking or he is talking or whatever too loudly.
13	If you have a concern about that, then you need to draw
14	that attention to me, and I will make a determination
15	whether or not I believe the person is speaking loudly.
16	If I think they are, I will ask them to whisper. If I do
17	not believe that they are then whispering quietly enough,
18	I will then advise them of that fact. And if necessary,
19	as I have just done, I will ask the jury to step outside.
20	Ms. Gutierrez, I will hear from you with regard
21	to your concern?
22	MS. GUTIERREZ: Judge, my notes reflect that
23	the exact words, after asking Mr. Wilds to identify the
24	plea agreement, of the question posed to this witness in
25	direct were the words "when you pled guilty" and there

was a followup question to that. This witness readily answered that. What I am seeking to get out and what I think I am entitled to for two reasons, this witness has been presented to this jury as not only a witness who has entered a plea agreement which then makes that the subject of impeachment, what the agreement was, how much it was limited to, whatever. But he has now been presented in direct as a witness who has pled quilty. In terminology, this witness has acceded he understands because he freely answered those questions, and there were four of them following that about the when he pled guilty.

In fact, this witness has not entered a guilty plea. I don't have a copy of my rules but I did review this before.

THE COURT: Was it an Alford plea?

MS. GUTIERREZ: No, Judge, it was a proceeding, a most remarkable proceeding, and I have sent for the transcript. There is a video transcript available but I believe that that is still with the court reporter. That was the subject of another motion before the previous trial that shows that on September 8th Mr. Urick, who appears in the video, Ms. Benaroya, and Mr. Jay Wilds appeared on an undocketed matter before Judge McCurdy, and that at that proceeding Mr. Wilds was purported to

1 enter a guilty plea.

However, the proceeding only indicates that' 2 Judge McCurdy asked him what we generally refer to as the 3 litany in a guilty plea, does he know what he is giving up. All the questions are asked by Judge McCurdy. Mr. 5 Wilds answered. There were two questions to which Mr. Wilds had a question directly to Judge McCurdy about 7 something that he asked. Then at the space and time when 8 under the rules, in order to constitute a guilty plea, 9 the statement of facts would have been read, Judge 10 McCurdy turned to Mr. Urick and Mr. Urick said something 11 to the effect of there will be no statement of facts, at 12 which point the clerk intervened and asked Judge McCurdy, 13 because of course the clerk had already recorded it as a 14 quilty plea, and both she and Judge McCurdy realized, 15 well, it wasn't a guilty plea because there is no 16 statement of facts, and all we have done is a litany and 17 there is no finding, there can be no verdict, it isn't a 18 quilty plea, and there was a discussion about what to 19 call it on the court file since there was no statement of 20 facts. 21 I believe that the rules define what a quilty 22 plea is, and, frankly, Judge, I can't quite remember 23 where it is, but the rule specifically says a guilty plea 24 is constituted when, you know, there is an oath 25

administered, the person is advised what we generally, 1 you know, refer to as the litany, whether it's given, and 2 that can actually be given by the judge, the prosecutor, 3 or the defense attorney, to which the defendant purporting to enter the guilty plea is properly advised 5 of all the consequences and what constitutional and 6 statutory rights they are giving up by so entering. 7 There has to be a finding by a judge that that portion, 8 i.e. the defendant understanding the consequences of a 9 10 quilty plea, is made freely and voluntarily, and that then there are sufficient statement of facts on the 11 12 record that the judge can make a finding upon which to base a plea. 13 Absent any single one of those statutory 14 requirements, there is no such thing as a quilty plea. 15 If the court went and pulled the file, they would 16 discover that disposition in this case isn't marked 17 because they haven't even reached disposition. 18 continued hearing. But there has been no finding other 19 than on the litany that was given to the defendant, and 20 not a single word of facts upon which any court could 21 have based a finding that there are sufficient facts to 22 base a plea. 23 24 THE COURT: So you are saying that it wasn't a

quilty plea?

25

T	MS. GUITERREZ: Inac's right.
2	THE COURT: If it was
3	MS. GUTIERREZ: And I believe that that is
4	subject to impeachment now since this witness has
5	intentionally been presented to this jury for their
6	purposes as a man who believes he has not only entered
7	into a plea agreement but he has already entered a guilty
8	plea, and that's false, and that goes to his
9	understanding of what he has done, what he has admitted
10	to, what the consequences are. He could very well
11	challenge where I'm going if his lawyer would tell him
12	the truth, would tell him
13	MR. URICK: Objection.
14	MS. GUTIERREZ: that plea is worthless, it's
15	not a plea, it's not binding. There has been no finding
16	of facts.
17	THE COURT: But, Ms. Gutierrez, isn't it a fact
18	that the purpose of your questions is to determine
19	whether or not he has any bias, motive, interest in
20	testifying one way or another based on promises he
21	believes that he has, not whether
22	MS. GUTIERREZ: Yes, sir, and I plan to get
23	there.
24	THE COURT: Wait a minute. Not whether, in
25	fact, they are promises, whether or not they are, in

- fact, promises that will be kept to him, but whether or
- 2 not they are influencing his testimony today. So in that
- 3 regard, it really doesn't matter whether they called it a
- quilty plea or not but, rather, whether or not you have
- 5 the latitude to inquire into any promises that have been
- 6 made.
- 7 MS. GUTIERREZ: Well, that's why I asked the
- 8 questions in exactly the words --
- 9 THE COURT: That he stated, yes.
- MS. GUTIERREZ: -- that he was asked to
- 11 challenge his understanding and what it meant.
- 12 THE COURT: I understand, Ms. Gutierrez. Why
- don't we do this. Why don't we ask the State what they
- 14 call it because, as you have indicated, it would help you
- 15 inquire --
- 16 MS. GUTIERREZ: I will cite you the rule, 4-
- 17 242.
- 18 THE COURT: 242?
- 19 MS. GUTIERREZ: Yes.
- 20 THE COURT: It would help you in terms of
- 21 asking your questions if you knew it was a formal guilty
- 22 plea proceeding because, as you have indicated, the
- 23 witness should have been placed under oath. If it wasn't
- a formal guilty plea proceeding but some other proceeding
- 25 whereby they may have just recorded the signing of a plea

- agreement --1 MS. GUTIERREZ: They did not, Judge. 2 THE COURT: Well, I'm just saying. I don't 3 know what it was because I haven't had the benefit of 4 viewing the video as you have. 5 MS. GUTIERREZ: Well, I'm telling you as an 6 officer of the court what the video shows. 7 THE COURT: Okay. Why don't we ask the State 8 what they want to call it and whether or not there needs 9 to be some correction about the use of the term quilty 10 plea when asking or inquiring of this witness what it is 11 that they did. Mr. Urick, can you answer the court's 12 question? 13 MR. URICK: In simple legal terms, Your Honor, 14 when a person comes into court and enters his plea, he 15 enters his plea. This witness pled guilty. He pled 16 quilty under oath. It was made clear to him that he was 17 entering a guilty plea, that it would be a binding plea. 18 He was explained the procedures that would complete the 19 procedure at disposition. It was made clear to him that 20 those procedures were binding, that they could be done 21 without his presence, in his absence. Everything was 22 explained to him, you know, and he pled guilty, and it 23
- THE COURT: Okay. And so you are saying that

24

was recorded that he pled quilty on that occasion.

- it was a plea under, as we say, 4-242, which is the
- 2 guilty plea litany?
- 3 MR. URICK: Yes.
- THE COURT: Very well. There is your answer.
- 5 MS. GUTIERREZ: Judge, I will note that 242(c)
- says a court may accept a plea of guilty only after, and
- 7 it then goes on to cite a one, that the defendant is
- 8 pleading guilty voluntarily with an understanding of the
- 9 nature of the charge and the consequences of the plea
- and, two, that there is a factual basis for the plea. If
- 11 you go back up in the first sentence, the court must
- 12 determine by the construction of the exact sentence that
- 13 both one and two exist.
- 14 I will tell you that --
- THE COURT: Ms. Gutierrez, you are arguing Mr.
- 16 Wilds' point on appeal of his guilty plea. If, by some
- 17 reason, Judge McCurdy did not follow the 4-242 litany,
- 18 that's for another day and another court to decide.
- MS. GUTIERREZ: Well, Judge, my point for our
- 20 impeachment is not limited to one kind of attack. If
- 21 this witness believes he has entered a guilty plea that
- 22 is binding, and our position is that he may not know
- 23 whether or not it's binding or not, and he has stated and
- 24 presented himself to this jury as a man who has already
- 25 pled guilty and admitted through facts his own

- involvement. That's not true. There are no facts that
- 2 have had to be determined.
- We believe that is critical to the defense to
- 4 challenge the credibility of this witness.
- THE COURT: Ms. Gutierrez, may I make a
- 6 suggestion then, in light of your argument, that we will
- 7 do the following: I will allow you to inquire as to what
- 8 this witness recalls being done during his quilty plea
- 9 proceeding. That is, he has already said he wasn't under
- oath, and anything else that you would like to draw out.
- 11 Then in the instructions to the jury, I will be happy to
- advise the jury what a guilty plea is under the rules.
- 13 And if you would like to structure an instruction --
- MS. GUTIERREZ: I will do so.
- THE COURT: -- that would outline what a guilty
- 16 plea is, and then we can utilize it in that fashion,
- 17 because I think what you are trying to do is, at this
- 18 juncture, argue the law mixed with a witness who may not
- 19 know that certain procedures under 2-242 may or may not
- 20 have been followed.
- MS. GUTIERREZ: And I do understand the court's
- 22 point, Judge, but I will point out that's why I was so
- 23 careful --
- 24 THE COURT: I understand.
- MS. GUTIERREZ: -- to phrase the questions in

- the exact words that this witness has already answered
- that he indicates he understands. So I believe the court
- 3 is in error --
- 4 THE COURT: One moment.
- 5 MS. GUTIERREZ: -- ruling that we are mixing
- 6 facts.
- 7 THE COURT: One moment. I asked previously
- 8 that if you have a phone, a cell phone or a pager, that
- 9 you turn it off. Whoever's cell phone just went off,
- 10 leave the courtroom. Out. I'm not going to ask again
- 11 that you follow the rules of this court. If you have got
- 12 a pager, a cell phone, turn it off.
- MS. GUTIERREZ: And I guess I'm asking for the
- 14 court's guidance because my next series of questions are
- related to the questions that followed that. And, again,
- using the exact words that he has already answered
- 17 questions, that his understanding is that if he tells a
- 18 lie, it voids it. It voids his belief that he is
- 19 protected as under the guilty plea that he has already
- 20 testified to he believes exists.
- 21 THE COURT: Ms. Gutierrez, he doesn't know
- that, and that's just it.
- MS. GUTIERREZ: Except he was allowed to be
- asked that and answered that, and we should be allowed to
- challenge the credibility of his answers on direct.

- THE COURT: You will.
- MS. GUTIERREZ: Well, I guess --
- 3 THE COURT: You will.
- 4 MS. GUTIERREZ: -- that's what I'm asking the
- 5 corut.
- THE COURT: You will be able to do that, and
- 7 that's exactly what the court's instruction --
- 8 MS. GUTIERREZ: As to these questions.
- 9 THE COURT: And you will get to do that because
- 10 as to these questions --
- MS. GUTIERREZ: Most respectfully, Judge --
- 12 THE COURT: -- you will be able to argue it.
- MS. GUTIERREZ: -- I appreciate, you know, and
- 14 I will fashion an instruction. But an instruction does
- not supplant the viable method, the only approved method
- 16 for a defendant to challenge the credibility of his main
- 17 accuser, and that is to be subject to cross-examination
- 18 as to anything.
- 19 THE COURT: I just said you could do it. I
- 20 just said you could.
- MS. GUTIERREZ: Well, Judge, you just said I
- 22 could do it --
- 23 THE COURT: I'm saying yes.
- 24 MS. GUTIERREZ: -- through the instructions.
- 25 THE COURT: No. I said yes, that you can

- 1 question.
- MS. GUTIERREZ: I can answer those exact
- 3 questions --
- 4 THE COURT: You can ask.
- 5 MS. GUTIERREZ: -- in the same --
- THE COURT: You can ask.
- 7 MS. GUTIERREZ: All right. It's late, Judge.
- 8 THE COURT: Yes.
- 9 MS. GUTIERREZ: Okay.
- 10 THE COURT: Yes.
- MS. GUTIERREZ: That's fine. I'll take it.
- 12 I'll take it.
- THE COURT: Yes, you can ask him if the
- 14 guestions, what you know to be a Rule 11 litany --
- MS. GUTIERREZ: Right.
- 16 THE COURT: -- a Rule 242 litany --
- 17 MS. GUTIERREZ: Right.
- 18 THE COURT: -- if those questions were asked
- 19 you, yes, you may ask the witness. You can even ask him
- again, you know, and I won't sustain the objection again
- 21 to were you under oath.
- MS. GUTIERREZ: Right.
- THE COURT: Yes, you may do that.
- MS. GUTIERREZ: Okay.
- 25 THE COURT: And then also if you would like to

- fashion an instruction that goes to what normally under
- 2 242 should be done in a guilty plea as an issue directed
- at credibility of a witness, because in order for the
- jury to assess his credibility, they need to know under
- 5 the law what should have been asked, and they would not
- 6 know unless you fashion an instruction.
- 7 So, yes, and yes. I don't know how better to
- 8 tell you. I am giving you what you are asking for.
- 9 MS. GUTIERREZ: Okay. I'll take it. Thanks,
- 10 Judge.
- 11 THE COURT: Well, you're welcome. Now, if we
- can have the jury come back in, we will continue with
- this case. I know that the State may not agree but the
- 14 court's concern is that if this witness believes that he
- was engaged in a guilty plea and that, as a result of
- 16 that guilty plea, that this promise is binding in some
- fashion and that is directing his testimony, the defense
- 18 has a right to inquire as to the basis for that belief.
- And if for some reason it is a faulty belief, then the
- jury is entitled to hear what it is that may have
- 21 happened during a guilty plea that this witness does not
- 22 either recall or may have forgotten or was not done, and
- opens him up to a challenge to his credibility.
- 24 For that reason, I will allow the defense to
- 25 inquire.

- MS. GUTIERREZ: Thank you, Your Honor. Since
- the jury isn't here, but while we are waiting for them, I
- guess I would ask for the court's guidance. Obviously I
- 4 can't finish my cross of this witness today.
- 5 THE COURT: I know.
- MS. GUTIERREZ: Are you still going to stop at
- 7 5:00?
- 8 THE COURT: I am.
- 9 MS. GUTIERREZ: I will try to structure it so I
- 10 finish pieces together.
- 11 THE COURT: Right.
- MS. GUTIERREZ: Okay.
- THE COURT: I am going to stop at 5:00, and you
- can piece it the way you would like to be the most
- 15 cohesive. I know that we have to stop somewhere.
- 16 (Brief pause.)
- 17 (The jury returned to the courtroom.)
- 18 THE COURT: All right. Ladies and gentlemen,
- 19 as you are finding your seat, we are going to proceed
- 20 with the testimony of Mr. Wilds.
- Ms. Ms. if you can ask Mr. Wilds to
- 22 return to the courtroom.
- 23 (Brief pause.)
- 24 THE COURT: Sir, please take the stand. I'll
- 25 remind you that you are still under oath. Have a seat.

- 1 Ms. Gutierrez, witness with you.
- MS. GUTIERREZ: Thank you, Your Honor.
- 3 CROSS-EXAMINATION (Continuing)
- BY MS. GUTIERREZ:
- 5 Q Mr. Wilds, again talking about what you have
- 6 called the plea agreement, okay?
- 7 A Yes, ma'am.
- 8 Q That's the same agreement that you have called
- 9 the truth agreement, correct?
- 10 A Yes, ma'am.
- 11 Q It would be fair to say that you believe that
- you are protected, that you can only get a certain amount
- of time as long as you don't tell a lie; is that correct?
- 14 A Yes, ma'am.
- Q But the day after you entered into this so-
- called truth agreement, you went in front of a judge,
- 17 correct?
- 18 A Yes, ma'am.
- 19 Q And it's your recollection that you didn't have
- to take an oath to tell the truth, correct?
- 21 A Yes, ma'am.
- 22 Q But that judge asked you some questions, did he
- 23 not?
- 24 A Yes, ma'am.
- Q And he asked you those questions in the

- 1 presence of your lawyer, did he not?
- 2 A Yes, ma'am.
- 3 Q And in fact he reminded you that since you had
- a lawyer, that if you had any concerns, you could consult
- 5 with your lawyer before answering any of those questions,
- 6 did he not?
- 7 A Yes, ma'am.
- 8 Q And you answered him, did you not?
- 9 A Yes, ma'am.
- 10 Q And you answered his questions about did you
- understand what you were doing there, correct?
- 12 A Pardon me.
- 13 Q He asked you if you understood why you were
- 14 there, did he not?
- 15 A Yes.
- 16 Q And you answered him that you did, did you not?
- 17 A Yes.
- 18 Q That you were attempting to enter a plea of
- 19 guilty pursuant to your truth agreement of the day
- 20 before, correct?
- 21 A Pursuant? I'm not understanding pursuant. I'm
- 22 sorry.
- Q Well, on September the 7th, you entered into by
- 24 signing this agreement, State's Exhibit 35; is that
- 25 right?

- 1 A Yes.
- 2 Q The four pages that you have initialed; is that
- 3 correct?
- 4 A Yes.
- 5 Q And this agreement requires your agreement to
- 6 cooperate in a certain way, does it not?
- 7 A Yes, ma'am.
- 8 Q And it requires that you testify, does it not?
- 9 A Yes, ma'am.
- 10 Q At any trial or proceeding that Mr. Urick
- 11 decides is important, does it not?
- 12 A I don't know who decides, but yes, ma'am.
- Q Well, you don't get to decide, correct?
- 14 A Correct.
- 15 Q The State's Attorney's Office gets to decide,
- 16 correct?
- 17 A Correct.
- 18 Q And that is laid right out in this so-called
- 19 truth agreement, is it not?
- 20 A Yes, ma'am.
- 21 Q And you initialed that and you signed it, did
- 22 you not?
- 23 A Yes, ma'am.
- Q And you had a lawyer before you did it, did you
- 25 not?

- 1 A Yes, ma'am.
- 2 Q And she of course told you that you were
- agreeing to testify at any proceeding you were asked, did
- 4 she not?
- 5 A No, ma'am.
- 6 Q You understood that, did you not?
- 7 A Yes, ma'am.
- 8 Q You initialed the page that says that, right?
- 9 A Yes, ma'am.
- 10 Q Even though your lawyer didn't talk to you
- about that particular clause, correct?
- 12 A It was understood, ma'am.
- Q Well, it not only was understood, the agreement
- 14 says it, does it not?
- 15 A Yes, ma'am.
- 16 Q It says that you agree to make yourself
- 17 available as needed, does it not?
- 18 A Yes, ma'am.
- 19 Q And that you are responsible for making sure
- 20 the State knows how to find you?
- 21 A Correct.
- 22 Q Since you are not in jail, at their pleasure,
- 23 right?
- 24 A Correct.
- 25 Q You have to let them know where you are all the

- time, correct?
- 2 A Yes.
- 3 Q And then you have to come anytime that they
- 4 want you, right?
- A Yes, ma'am.
- 6 Q And you understood that?
- 7 A Yes, ma'am.
- 8 Q Did you not?
- 9 A Yes, ma'am.
- 10 Q Further, to cooperate, you said that you would
- tender a guilty plea at sometime in the future to the
- 12 count of an accessory after the fact to the murder of Hae
- 13 Min Lee; isn't that correct?
- 14 A Yes, ma'am.
- 15 Q And you understood what that meant, did you
- 16 not?
- 17 A Yes, ma'am.
- 18 Q Correct?
- 19 A Yes, ma'am.
- 20 Q In fact, your plea agreement says that you
- 21 fully understand the maximum penalties and fines for that
- 22 charge, does it not?
- 23 A Yes, ma'am.
- Q You signed and initialed on that third page,
- 25 did you not?

- 1 A Yes, ma'am.
- 2 Q And the full maximum penalty that you faced as
- an accessory after the fact is?
- A I believe it was five years, ma'am.
- 5 Q Five years. And that was explained to you, was
- 6 it not?
- 7 A Yes, ma'am.
- 8 Q And an accessory after the fact, you understood
- 9 in part based on conversations with your lawyer, did you
- not, that an accessory after the fact is held to a lesser
- standard in regard to punishment than an actual murderer,
- 12 did you not?
- 13 MR. URICK: Objection.
- 14 THE COURT: I'll sustain as to the legal
- 15 understanding.
- BY MS. GUTIERREZ:
- 17 Q Well, you understood that an actual murderer is
- subject to far more than five years, did you not?
- 19 MR. URICK: Objection.
- 20 THE COURT: Sustained.
- 21. BY MS. GUTIERREZ:
- 22 Q You also understood that you specifically
- agreed to testify at any trial where you were asked that
- 24 concerned Adnan Syed, did you not?
- 25 A Yes, ma'am.

- 1 Q That was part of your agreement, was it not?
- 2 A Yes, ma'am.
- 3 Q And you were asked by Judge McCurdy the day
- 4 after you signed this agreement if you understood the
- 5 terms of your plea agreement, were you not?
- A Yes, ma'am.
- 7 Q And that you had signed on to do so; is that
- 8 correct?
- 9 A Yes, ma'am.
- 10 Q And that you understood that there would be
- both a guilty plea and a disposition sometime far in the
- 12 future; isn't that correct?
- 13 A Yes, ma'am.
- 14 Q After your testimony, correct?
- A After I fulfilled my obligation, yes.
- 16 Q And who decided whether or not you fulfilled
- 17 your obligation, sir?
- 18 A The State.
- 19 Q The State, Mr. Urick; is that right?
- 20 A Yes, ma'am.
- Q So if you testified and Mr. Urick was satisfied
- 22 with it, then that would meet the terms of their
- 23 obligation under this, correct?
- 24 A Incorrect.
- 25 Q Correct?

- 1 A Incorrect.
- 2 Q Incorrect. So if you testified and Mr. Urick
- 3 was satisfied with your testimony, would you expect them
- to meet their obligations under this plea agreement?
- A No, ma'am, that is also incorrect.
- 6 Q My question called for a yes or no.
- 7 A No, ma'am.
- 8 Q So the answer to my question is no?
- 9 THE COURT: Ms. Gutierrez, please move on. I
- think he said that is not correct. Next question.
- 11 BY MS. GUTIERREZ:
- 12 Q Now, were there any circumstances outlined in
- the plea agreement that gave you some assurance of
- whether or not Mr. Urick would meet his obligations?
- 15 A Yes.
- 16 Q And did you feel clear about understanding what
- 17 they were?
- 18 A Yes.
- 19 Q And was that understanding only that you would
- 20 tell the truth?
- 21 A Yes, ma'am.
- Q Okay. And when Judge McCurdy was questioning
- you about this plea agreement, you didn't have to take an
- 24 oath to tell the truth, right?
- 25 A No, ma'am, I did not.

- 1 Q It was up to you whether or not you told the
- 2 truth, right?
- 3 MR. URICK: Objection.
- 4 THE COURT: Overruled. Did you believe at the
- time that you made this thing that you are telling us
- about that it was up to you to decide whether to tell the
- 7 truth or not?
- 8 THE WITNESS: Yes, ma'am.
- 9 BY MS. GUTIERREZ:
- 10 Q Okay. And your being in charge of deciding
- whether to tell the truth was not a new experience for
- 12 you, was it?
- 13 A May I ask a question?
- 14 Q No, sir, you may not.
- 15 A I'm sorry.
- 16 THE COURT: No, no, no, no, if you do not
- 17 understand her question --
- 18 THE WITNESS: I do not understand.
- 19 THE COURT: -- then you can say I don't
- understand. If you don't hear it, you can say will you
- 21 repeat your question.
- THE WITNESS: I do not understand.
- 23 THE COURT: Okay.
- 24 BY MS. GUTIERREZ:
- 25 Q Sir, my question is your being in charge of

- whether or not you tell the truth is not a new experience
- 2 for you, is it?
- MR. URICK: Objection.
- THE COURT: Sustained.
- BY MS. GUTIERREZ:
- 6 Q Mr. Wilds, prior to signing on September the
- 7 7th this truth agreement, had you had to take an oath in
- 8 regard to these matters before?
- 9 A No, ma'am, I did not.
- 10 Q You had spoken to the police on at least three
- occasions, had you not?
- 12 A Yes, ma'am.
- Q And on at least two of those occasions, they
- tape recorded what you said, did they not?
- 15 A Yes, ma'am.
- 16 Q And you were aware of that, were you not?
- 17 A Yes, ma'am.
- 18 O The very first occasion you were asked to speak
- 19 and your statement was tape recorded started at 1:30 a.m.
- on February 28th, did it not?
- 21 A Yes, ma'am.
- Q That's 1:30 in the middle of the night, is it
- 23 not?
- 24 A Yes, ma'am.
- 25 Q And you weren't down at the police station

- 1 voluntarily, were you?
- A No, ma'am.
- 3 Q And there was no court clerk or judge in the
- 4 room, was there?
- A No, ma'am.
- 6 Q And nobody administered an oath to you, did
- 7 they?
- 8 A No, ma'am.
- 9 Q And you weren't there of your own volition,
- 10 were you?
- 11 A No, ma'am.
- 12 Q You were brought there, were you not?
- 13 A Yes, ma'am.
- 14 Q You were picked up by the police, were you not?
- 15 A Yes, ma'am.
- 16 Q And you were brought in the middle of the night
- 17 to the Homicide Unit, were you not?
- 18 A Yes, ma'am.
- 19 Q And no one, including any of the detectives,
- administered an oath and asked you to swear to tell the
- 21 truth, did they?
- 22 A No, ma'am.
- 23 Q And you didn't, did you?
- 24 A No, ma'am.
- Q No. And in fact during that first statement,

- during the time it was being recorded, there came a time
- when you asked them to turn off the recorder, did you
- 3 not? Was there not such a time?
- 4 A I believe so.
- 5 Q And that was your doing, was it not?
- A Yes, ma'am.
- 7 Q They didn't suggest to you that that was
- 8 something you should do, was it?
- 9 A No.
- 10 Q And you are --
- 11 A Oh, I'm sorry.
- 12 Q -- deciding not --
- 13 THE COURT: One moment. What were you about to
- 14 say?
- THE WITNESS: Yes, they did tell me I could
- 16 stop at any time I liked.
- 17 BY MS. GUTIERREZ:
- 18 Q And you took advantage of that, didn't you?
- 19 A Yes, ma'am.
- 20 Q And stopping meant turning off that recorder
- 21 that was recording what you said, correct?
- 22 A Yes, ma'am.
- 23 Q And at the time, you knew you were lying to the
- 24 police, did you not?
- 25 A Yes, ma'am.

- 1 Q But they didn't know it, did they?
- 2 A I do not believe so.
- 3 Q You were in charge of whether or not you told
- 4 the truth, correct?
- 5 A Yes, ma'am.
- 6 Q No one else was, right?
- 7 A Correct.
- 8 Q And on that occasion when you were in charge of
- 9 whether or not you told the truth, you lied, did you not?
- 10 A Yes, ma'am.
- 11 Q You lied about a number of things, did you not?
- 12 A Yes, ma'am.
- 13 Q And being hauled down by the police not of your
- own calling in the middle of the night was not a surprise
- 15 to you, was it?
- 16 A Yes, ma'am, it was.
- Q Well, on this February 27th -- February 28th
- 18 was a Sunday, was it not?
- 19 A I do not recall.
- Q Okay. Well, sir, do you recall that on
- 21 February 27th your good friend, Jenn , also
- 22 appeared in the same office of the Baltimore City Police
- 23 Department on Fayette Street?
- 24 A Yes, ma'am.
- 25 Q You were aware of that, were you not?

- 1 A Yes, ma'am.
- 2 Q You were aware of that before it happened,
- 3 weren't you?
- A No, ma'am, I was not.
- 5 Q Well, you recall, sir, that you had a
- 6 conversation with your very good friend, Jenn
- 7 about what was going to be covered in her conversation
- 8 with the police the day before on February 26th, which
- 9 was a Friday? You recall that, do you not?
- 10 A No, ma'am.
- 11 Q You recall that Jenn came to you
- 12 panicked because the police wanted to talk to her. Do
- 13 you recall that?
- 14 A Yes, ma'am, I do.
- 15 Q And that happened on February 26th, did it not?
- A She came to me and stated that the police
- 17 wanted to talk to her, yes.
- 18 Q And you understood that she had said minimal
- 19 things to the police, did you not?
- 20 A No, I did not.
- 21 Q You were aware because she told you what she
- 22 said, did she not?
- A No, she did not.
- 24 Q She discussed with you whether she should speak
- 25 to them again, did she not?

- 1 A Yes.
- 2 Q And you were aware of what the police wanted to
- 3 talk to her about, correct?
- 4 A Yes.
- Now, you were aware, as you have told us, you
- 6 had been with Jenn sometime around that time,
- 7 correct?
- 8 A Yes.
- 9 Q And you had spoken to her on those days, had
- 10 you not?
- 11 A Yes.
- 12 Q And sometime before she spoke to the police
- when you became aware they wanted to speak to her, you
- conversed with her actually about that, did you not?
- 15 A Yes, ma'am.
- Q And you did so at her request, correct?
- 17 A I believe so.
- 18 Q And you were aware, before she appeared at the
- 19 very same place you were hauled down to the next evening,
- that she had chosen to talk to the police, were you not?
- 21 A No, ma'am, I was not.
- 22 Q You were aware what she was going to say, were
- 23 you not?
- 24 A No, ma'am, I was not.
- Q And you were aware that she appeared on

13	are scheduled to leave by airplane or train or bus or are
14	you driving?
15	JUROR NUMBER SIX: It's by bus.
16	THE COURT: Okay. And is it a scheduled time
17	of departure on Friday?
18	JUROR NUMBER SIX: Yes, it is.
19	THE COURT: What time?
20	JUROR NUMBER SIX: It's 6:00 in the morning.
21	THE COURT: That's a.m?
22	JUROR NUMBER SIX: Yes.
23	THE COURT: And you will return on the 13th?
24	JUROR NUMBER SIX: Yes.

THE COURT: Okay. We are aware of that

- 1 situation and we are going to try to work around that
- 2 schedule to the best that we can. We will advise you if
- 3 we are unable to do that.
- 4 JUROR MUMBER SIX: Okay.
- 5 THE COURT: All right?
- 5 JUROR NUMBER SIX: All right.
- 7 THE COURT: Does that answer your question?
- 8 JUROR NUMBER SIX: Yes, it does.
- 9 THE COURT: Very well. You may go.
- 10 JUROR NUMBER SIX: Thank you.
- 11 THE COURT: We will see you on Tuesday.
- JUROR NUMBER SIX: All right. Thank you.
- 13 (Whereupon, the juror was excused from the
- 14 courtroom.)
- 15 THE COURT: Okay. And now counsel has a
- 16 question.
- 17 MS. BENAROYA: Yes, Your Honor.
- 18 THE COURT: I need you to come up to the bench.
- 19 Is it regarding your witness or client?
- 20 MS. HENAROYA: Your Honor, I represent him on a
- 21 pro bono basis.
- 22 THE COURT: I understand. One moment.
- 23 Counsel, I will see you at the bench.
- 24 MS. BENAROYA: Okay. This is --
- 25 THE COURT: No, no, no, you need to wait a

- 1 moment because if you need to speak to me, counsel needs
- 2 to be present because I am not going to talk to you
- 3 without them being present.
- 4 MS. BENAROYA: Okay.
- 5 (Counsel and the defendant approached the bench
- 6 and the following ensued:)
- 7 THE COURT: Okay. Now, please identify
- 8 yourself for the record.
- 9 MS. BEMAROYA: Okay. For the record, Anne
- 10 Benaroya.
- 11 THE COURT: Keep your voice down.
- 12 MS. BENAROYA: Anne Benaroya. That's B-E-N-A-
- 13 R-O-Y-A. I am pro bono counsel for Jay Wilds. My
- 14 question to the court is purely straight forward. As I
- 15 have mentioned, Mr. Wilds is my client on a pro bono
- 16 basis. I have put a great deal of time and resources
- 17 into the case. I provide him with transportation to and
- 18 from court. There has been an unserved subpoena that Ms.
- 19 Gutierrez -- this was before the other case, the first
- 20 case was tried. I received a call from a process server.
- 21 I live in Rockville. The process server contacted me and
- 22 said he had a subpoens to serve me. I said, well, that's
- 23 fine. Well, I never got it. So I am unserved.
- 24 What I need to know is, do I need to respond to
- 25 this subpoena? Shall I file a motion to quash in

- writing? I called Ms. Gutierrez and asked her why she
- 2 subpoenaed me, and she didn't wish to discuss it with me.
- 3 Because I'm doing this on a pro bono basis -- I do have
- many other obligations -- I'm asking the court how to
- 5 deal with this? Shall I file a motion to guash? Maybe
- 6 Ms. Gutierrez --
- 7 THE COURT: I'm not going to advise you how to
- 8 deal with it, but I can tell you that if you do receive a
- 9 subpoena, you will be under order of this court to be
- 10 here. If you have any problem appearing, you can write
- the court and inquire or request that I deal with your
- request in some form or fashion. But if the defense does
- 13 subpoena you, and you receive a subpoena to be here --
- MS. BENAROYA: Okay. I'm not served as of now.
- THE COURT: Counsel, if you have other clients
- or other matters, I would be happy to work around your
- 17 schedule. But the defense, if they choose to call you,
- may call you in the defense. Well, you are still in the
- 19 State's case.
- MS. BENAROYA: Yes.
- 21 THE COURT: So I can tell you that between now
- and probably the middle of next week, you will probably
- 23 not be called. However, your client is still on the
- 24 witness stand and will remain on the witness stand on
- Tuesday, that is starting Tuesday at 9:30.

- MS. BENAROYA: Yes, I'll be bringing him to
- 2 court.
- 3 THE COURT: So as a result of bringing him to
- 4 court, you may be served.
- 5 MS. BENAROYA: Yes, that's right.
- 6 THE COURT: And if you are served and it is
- 7 causing you some scheduling conflict with other cases or
- 8 proceedings, then I need to have you write me and
- 9 indicate what they are so that we can work around your
- 10 schedule.
- MS. BENAROYA: Okay. That was all I needed to
- 12 know.
- 13 THE COURT: Fine. Any problem with that, Ms.
- 14 Gutierrez?
- MS. GUTIERREZ: No.
- 16 THE COURT: And Ms. Gutierrez has been kind
- enough, and so has Mr. Urick, that at which time she has
- determined that she does no longer need a witness, as you
- 19 have been hearing, we have been excusing witnesses and
- 20 releasing them from summonses as the case may be. So I
- 21 will ask that that happen, as you have done I think with
- 22 one of the doctors or police officers actually --
- MS. GUTIERREZ: Yes.
- 24 THE COURT: -- who indicated that he had a
- 25 conflict, and we worked around that as well.

MS. BENAROYA: Okay. Very good. Thank you. 1 THE COURT: All right. 2 MS. BENAROYA: That's all I needed. 3 THE COURT: Very well. Anything further? 4 5 . (No response.) THE COURT: Okay. Thank you. 6 7 (Counsel and the defendant returned to the trial tables and the following ensued:) 8 THE COURT: Okay. Then Tuesday at 9:30. • Yes, 9 I see you are taking a deep breath. Is there a problem? 10 MR. URICK: Well, just so everyone is aware, I 11 have got a witness scheduled for Tuesday who is scheduled 12 to be out of town Wednesday, Thursday, and Friday. I 13 may, if Ms. Gutierrez goes into the afternoon, I may ask 14 to take him out of order and interrupt the cross-15 examination and put him on so I can get him off. 16 MS. GUTIERREZ: Who is that witness? 17 MR. URICK: Abe . I will get the 18 spelling to you later. 19 20 THE COURT: And I can give you a list of all the witnesses from the voir dire. 21 COURT REPORTER: Thank you. 22 THE COURT: Okay. 23 MS. GUTIERREZ: Judge, I have no objection to 24

taking a witness out of turn. I do have an objection to

- interrupting Mr. Wilds' testimony again. You know, he is
- 2 the main witness.
- THE COURT: Yes.
- 4 MS. GUTIERREZ: I don't know how long my cross
- 5 is going to take.
- THE COURT: I'm not going to limit your cross.
- 7 MS. GUTIERREZ: What I would suggest, what I
- 8 would be open to, is if on Tuesday morning if he would
- 9 rather put that witness on out of turn before we start
- 10 back with Mr. Wilds, I wouldn't object to that.
- MR. URICK: That would be fine.
- MS. GUTIERREZ: You know, so that we then don't
- interrupt Mr. Wilds a second time.
- 14 THE COURT: Obviously, if Ms. Gutierrez is
- 15 acquiescing to that procedure --
- MR. URICK: That's fine.
- 17 THE COURT: That's why I advised her of the
- 18 time, so that she could take her cross in chunks, which
- 19 she has done. So if you would like to do that on Tuesday
- 20 morning, you can do that as well.
- MR. URICK: Thank you.
- 22 THE COURT: All right. Anything else?
- 23 (No response.)
- 24 THE COURT: You all have a good weekend. I'll
- 25 see you on Tuesday.

1	MR. URICK: Thank you, Your Honor.
2	THE COURT: But I will be back on Monday.
3	Staff, I will see you on Monday at 9:30. There is a
4	schedule of the hearings. You can check with my staff.
5	THE CLERK: I have the schedule, Your Honor.
6	THE COURT: You have got the schedule. Very
7	well. We stand in recess then until Monday at 9:30.
8	THE CLERK: All rise.
9	(Whereupon, at 5:20 p.m., the trial recessed.)
