2	(2:10 p.m.)
3.	(Jury not present upon reconvening.)
4	THE CLERK: All rise. The Circuit Court for
5	Baltimore City, Part 9, will now resume in session, the
6	Honorable Wanda Keyes Heard presiding.
7	THE COURT: You may be seated. I understand
8	that we are going to wait for a few moments to have the
9	jury come around and Ms. Gutierrez to return. The next
10	witness that you are going to be calling is
11	MR. URICK: Is Jay Wilds.
12	THE COURT: Jay Wilds.
13	MR. URICK: Should I have him come in and sit
14	on the stand?
15	THE COURT: Yes, that would be good. That way
16	he will already be here.
17	(Brief pause.)
18	THE COURT: Mr. Wilds, just have a seat there.
19	When the jury comes out, we will have you stand and be
20	sworn. Okay?
21	MR. WILDS: Yes.
22	THE COURT: Thank you.
23	(Brief pause.)
24	THE COURT: Also, with regard to the schedule

that I handed out, do counsel have any objection if I

- 1 make copies of that for the jury.
- 2 MR. URICK: No.
- 3 MS. GUTIERREZ: No, Judge, I think that would
- 4 be helpful to the jury.
- 5 THE COURT: All right.
- 6 MS. GUTIERREZ: I would like, before the jurors
- 7 get in, in regard to this witness, I would ask that the
- 8 court advise the witness -- the mistrial occurred during
- 9 this witness' testimony -- that any reference to anything
- 10 prior should be at a prior occasion, that there be no
- 11 reference to --
- 12 THE COURT: Right, Ms. kind of bordered
- 13 on that a little bit.
- MS. GUTIERREZ: Right.
- 15 THE COURT: But I don't think it was clear from
- 16 anything she said.
- MS. GUTIERREZ: That's why I did not -- I
- 18 thought it would make it worse if I did.
- 19 THE COURT: That's a good idea.
- 20 MS. GUTIERREZ: But this witness I am concerned
- 21 about.
- 22 THE COURT: Mr. Wilds, would you step up to the
- 23 bench, please.
- 24 (Whereupon, Mr. Jay Wilds approached the bench
- 25 and the following ensued:)

1	THE COURT: Mr. Wilds, you cannot make any
2	mention at anytime during the trial that there was
3	another trial.
4	MR. WILDS: Okay.
5	THE COURT: Do you understand what I'm saying?
6	MR. WILDS: Yes.
7	THE COURT: Pretend this is the first trial.
8	MR. WILDS: Yes, ma'am.
9	THE COURT: Okay. They can't know there was
10	another one.
11	MR. WILDS: Okay.
12	THE COURT: Thank you.
13	(Whereupon, Mr. Jay Wilds returned to the
14	witness chair and the following ensued:)
15	(Brief pause.)
16	(The jury returned to the courtroom.)
17	THE COURT: Just have a seat for just one
18	moment, Mr. Wilds. Can I see counsel at the bench for
19	one second.
20	(Counsel and the defendant approached the bench
21	and the following ensued:)
22	THE COURT: Okay. First things first. I was
23	just informed by my sheriff that the defendant made a
24	comment to the witness as the witness approached the

stand indicating that he was pathetic. I want to advise

- 1 Mr. Syed in your presence that up until now he has been
- 2 perfect. He has conducted himself in a gentlemanly
- manner. I am going to advise you now, don't spoil it
- now. Whatever self-control you need to exhibit, continue
- 5 to do it to the end of this trial. You are presenting
- 6 yourself in a manner that is appropriate in this
- 7 courtroom, and you don't want me to have to say anything
- 8 to you.
- 9 Do you understand?
- 10 THE DEFENDANT: Yes.
- 11 THE COURT: Very well. I am not saying your
- 12 client did or did not do it.
- MS. GUTIERREZ: I understand.
- 14 THE COURT: But I am advising you, and I know
- 15 you don't want your client to do anything inappropriate
- 16 in front of the jury.
- 17 MS. GUTIERREZ: No.
- 18 THE COURT: And I am letting the State know
- 19 because I want to make sure that the witness understands
- that his safety is not in any way in jeopardy when he
- 21 testifies in this courtroom because I don't allow that to
- 22 happen. Whether that be for a defense witness or for a
- 23 State witness, we will not have that here. We all know
- 24 this. We have been through this before. The sheriff
- 25 doesn't know, but Deputy Church was aware, and so he

- 1 handled it accordingly. So now this sheriff knows, and
- 2 I'm sure she will make sure she sits in a way that she is
- 3 alert to what may occur.
- I just want everybody to know. Okay. We will
- 5 continue as we have been going.
- 6 MR. URICK: I believe at this point I would be
- 7 entitled to question the witness about any statements the
- 8 defendant made to him today in the courtroom.
- 9 THE COURT: I will not allow you to use any
- 10 statements that he may have made today in the courtroom.
- I will not allow it. We are not going to have last
- 12 minute additions. We will not have that. If it was a
- 13 statement that was made or uttered to that witness, I
- 14 will not allow that witness to testify as to what was
- 15 said. That witness, as a defendant, is represented by
- 16 counsel and I am not going to allow it. I'm not going to
- 17 allow it.
- 18 Now, you can take your exception for the
- 19 record, but I am not going to allow that.
- 20 MR. URICK: I would for this reason, that this
- 21 witness is not a State agent. It was a voluntary
- 22 statement to a non-State witness.
- 23 THE COURT: I understand.
- MR. URICK: Or non-State agent.
- 25 THE COURT: I understand. The sheriff also

- 1 heard it, and for the record, if the sheriff heard the
- 2 remark, then the sheriff could be called as a witness.
- 3 But at this juncture, the court is not going to allow the
- sheriff to do anything other than to let me know, as I
- 5 have indicated to you, what was said to the witness.
- 6 Okay. I just would like you to go ahead and
- 7 try your case. You have got a case, try your case.
- 8 MR. URICK: Just to make the record, the second
- 9 point would be the relevance because it would relate to a
- 10 threat that he made to the witness while he was trying to
- 11 testify.
- 12 THE COURT: Well, that might be something that
- you might bring up if the door is opened by the defense.
- 14 That's a wholly different issue. But as the case stands
- 15 right now, we don't have that.
- 16 MR. URICK: Thank you.
- 17 THE COURT: Unless you would like me to inquire
- of the witness outside the presence of the jury as to
- 19 whether or not any statement that he may or may not have
- 20 heard -- I don't even know if the witness heard what was
- 21 said. For all I know, the witness didn't hear anything.
- 22 I don't know, I haven't inquired of him. The only thing
- I do know is the sheriff heard it.
- 24 So if you would like me to inquire of the
- 25 witness as to whether the witness heard anything, I will

1	be happy to do that.
2	MR. URICK: No, Your Honor.
3	THE COURT: But the point I'm trying to make
4	is, we are trying to try a case based on your case and
5	based on the defense. As long as this is a small
6	courtroom, we are going to have situations where we are
7	in close quarters. So we are going to provide safety and
8	security for everyone.
9	Okay. Let's proceed. Thank you.
10	(Counsel and the defendant returned to the
11	trial tables and the following ensued:)
12	THE COURT: Mr. Urick, if you will call the
13	name of your witness, please, for the record.
14	MR. URICK: Thank you, Your Honor. The State
15	calls Jay Wilds at this time.
16	JAY W. WILDS
17	a witness produced on call of the State, having first
18	been duly sworn according to law, was examined and
19	testified as follows:

- 10 that he told me, and I was like all right, cool. I
- waited until then and there was no phone call, so I was
- 12 going to my friend Jeff's house.
- 13 Q And on the way there, what if anything
- 14 happened?
- 15 A Jeff wasn't home. As I was leaving his street,
- I received a phone call. It was Adnan. He asked me to
- 17 come and get him from Best Buy.
- 18 Q Where were you at that time?
- 19 A I was turning. I was going to make a right
- onto, I believe it was Craigmont, but instead I made a
- 21 left.
- 22 Q And where did you go?
- 23 A To Best Buy.
- Q And what if anything -- which Best Buy was

- 1 A The one at Security Boulevard and Woodlawn.

- 3 you see?
- A I saw Mr. Syed standing by the payphone. He
- 5 had on a pair of red gloves. He just kind of looked at

What I am seeking to get out and what I think I am entitled to for two reasons, this witness has 3 been presented to this jury as not only a witness who has 4 entered a plea agreement which then makes that the 5 subject of impeachment, what the agreement was, how much 6 it was limited to, whatever. But he has now been 7 presented in direct as a witness who has pled guilty. In 8 terminology, this witness has acceded he understands 9 because he freely answered those questions, and there 10 were four of them following that about the when he pled 11 12 guilty. In fact, this witness has not entered a guilty 13 plea. I don't have a copy of my rules but I did review 14 this before. 15 THE COURT: Was it an Alford plea? 16 17 MS. GUTIERREZ: No, Judge, it was a proceeding, a most remarkable proceeding, and I have sent for the 18 transcript. There is a video transcript available but I 19 believe that that is still with the court reporter. That 20

was the subject of another motion before the previous

trial that shows that on September 8th Mr. Urick, who

appears in the video, Ms. Benaroya, and Mr. Jay Wilds

appeared on an undocketed matter before Judge McCurdy,

However, the proceeding only indicates that' 2 Judge McCurdy asked him what we generally refer to as the 3 litany in a guilty plea, does he know what he is giving 4 up. All the questions are asked by Judge McCurdy. Mr. 5 Wilds answered. There were two questions to which Mr. 6 Wilds had a question directly to Judge McCurdy about 7 something that he asked. Then at the space and time when 8 under the rules, in order to constitute a guilty plea, 9 the statement of facts would have been read, Judge 10 McCurdy turned to Mr. Urick and Mr. Urick said something 11 to the effect of there will be no statement of facts, at 12 which point the clerk intervened and asked Judge McCurdy, 13 because of course the clerk had already recorded it as a 14 quilty plea, and both she and Judge McCurdy realized, 15 well, it wasn't a guilty plea because there is no 16 statement of facts, and all we have done is a litany and 17 there is no finding, there can be no verdict, it isn't a 18 quilty plea, and there was a discussion about what to 19 call it on the court file since there was no statement of 20 facts. 21 I believe that the rules define what a guilty 22 plea is, and, frankly, Judge, I can't quite remember 23 where it is, but the rule specifically says a guilty plea 24 is constituted when, you know, there is an oath 25

- administered, the person is advised what we generally, 1 you know, refer to as the litany, whether it's given, and 2 that can actually be given by the judge, the prosecutor, 3 or the defense attorney, to which the defendant 4 purporting to enter the guilty plea is properly advised 5 of all the consequences and what constitutional and 6 statutory rights they are giving up by so entering. 7 There has to be a finding by a judge that that portion, i.e. the defendant understanding the consequences of a 9 guilty plea, is made freely and voluntarily, and that 10 then there are sufficient statement of facts on the 11 record that the judge can make a finding upon which to 12 13 base a plea. 14 Absent any single one of those statutory requirements, there is no such thing as a guilty plea. 15 If the court went and pulled the file, they would 16 discover that disposition in this case isn't marked 17 because they haven't even reached disposition. It's a 18 continued hearing. But there has been no finding other 19 than on the litany that was given to the defendant, and 20 not a single word of facts upon which any court could 21 22 have based a finding that there are sufficient facts to
- 24 THE COURT: So you are saying that it wasn't a guilty plea?

base a plea.

T	MS. GUTTERREZ: That's right.
2	THE COURT: If it was
3	MS. GUTIERREZ: And I believe that that is
4	subject to impeachment now since this witness has
5	intentionally been presented to this jury for their
6	purposes as a man who believes he has not only entered
7	into a plea agreement but he has already entered a guilty
8	plea, and that's false, and that goes to his
9	understanding of what he has done, what he has admitted

21	believes that he has, not whether
22	MS. GUTIERREZ: Yes, sir, and I plan to get
23	there.
24	THE COURT: Wait a minute. Not whether, in

fact, they are promises, whether or not they are, in

- fact, promises that will be kept to him, but whether or
- not they are influencing his testimony today. So in that
- 3 regard, it really doesn't matter whether they called it a
- 4 guilty plea or not but, rather, whether or not you have
- 5 the latitude to inquire into any promises that have been
- 6 made.

- involvement. That's not true. There are no facts that
- 2 have had to be determined.
- 3 We believe that is critical to the defense to
- 4 challenge the credibility of this witness.
- 5 THE COURT: Ms. Gutierrez, may I make a
- 6 suggestion then, in light of your argument, that we will
- 7 do the following: I will allow you to inquire as to what
- 8 this witness recalls being done during his quilty plea
- 9 proceeding. That is, he has already said he wasn't under
- oath, and anything else that you would like to draw out.
- 11 Then in the instructions to the jury, I will be happy to
- advise the jury what a guilty plea is under the rules.
- 13 And if you would like to structure an instruction --
- MS. GUTIERREZ: I will do so.
- 15 THE COURT: -- that would outline what a quilty
- 16 plea is, and then we can utilize it in that fashion,
- 17 because I think what you are trying to do is, at this
- 18 juncture, argue the law mixed with a witness who may not
- 19 know that certain procedures under 2-242 may or may not
- 20 have been followed.
- 21 MS. GUTIERREZ: And I do understand the court's
- 22 point, Judge, but I will point out that's why I was so
- 23 careful --
- 24 THE COURT: I understand.
- MS. GUTIERREZ: -- to phrase the questions in

- 1 the exact words that this witness has already answered
- 2 that he indicates he understands. So I believe the court
- 3 is in error --
- 4 THE COURT: One moment.
- 5 MS. GUTIERREZ: -- ruling that we are mixing
- 6 facts.
- 7 THE COURT: One moment. I asked previously
- 8 that if you have a phone, a cell phone or a pager, that
- you turn it off. Whoever's cell phone just went off,
- 10 leave the courtroom. Out. I'm not going to ask again
- 11 that you follow the rules of this court. If you have got
- 12 a pager, a cell phone, turn it off.
- MS. GUTIERREZ: And I guess I'm asking for the
- 14 court's guidance because my next series of questions are
- 15 related to the questions that followed that. And, again,
- 16 using the exact words that he has already answered
- 17 questions, that his understanding is that if he tells a
- 18 lie, it voids it. It voids his belief that he is
- 19 protected as under the guilty plea that he has already
- 20 testified to he believes exists.
- 21 THE COURT: Ms. Gutierrez, he doesn't know
- 22 that, and that's just it.
- MS. GUTIERREZ: Except he was allowed to be
- 24 asked that and answered that, and we should be allowed to
- 25 challenge the credibility of his answers on direct.

THE COURT: You will. 1 MS. GUTIERREZ: Well, I guess --2 THE COURT: You will. 3 MS. GUTIERREZ: -- that's what I'm asking the corut. 5 THE COURT: You will be able to do that, and 6 7 that's exactly what the court's instruction --MS. GUTIERREZ: As to these questions. 8 THE COURT: And you will get to do that because 9 as to these questions --10 MS. GUTIERREZ: Most respectfully, Judge --11 12 THE COURT: -- you will be able to argue it. MS. GUTIERREZ: -- I appreciate, you know, and 13 I will fashion an instruction. But an instruction does 14 15 not supplant the viable method, the only approved method for a defendant to challenge the credibility of his main 16 accuser, and that is to be subject to cross-examination 17 18 as to anything. THE COURT: I just said you could do it. I 19 just said you could. 20 MS. GUTIERREZ: Well, Judge, you just said I 21 could do it --22 THE COURT: I'm saying yes. 23

MS. GUTIERREZ: -- through the instructions.

THE COURT: No. I said yes, that you can

24

- 3 questions --
- 4 THE COURT: You can ask.
- MS. GUTIERREZ: -- in the same --

- 14 questions, what you know to be a Rule 11 litany --
- 15 MS. GUTIERREZ: Right.
- 16 THE COURT: -- a Rule 242 litany --
- 17 MS. GUTIERREZ: Right.
- 18 THE COURT: -- if those questions were asked
- 19 you, yes, you may ask the witness. You can even ask him
- 20 again, you know, and I won't sustain the objection again
- 21 to were you under oath.
- MS. GUTIERREZ: Right.
- 23 THE COURT: Yes, you may do that.
- 24 MS. GUTIERREZ: Okay.
- 25 THE COURT: And then also if you would like to

- fashion an instruction that goes to what normally under
  2 242 should be done in a guilty plea as an issue directed
  3 at credibility of a witness, because in order for the
  4 jury to assess his credibility, they need to know under
- 5 the law what should have been asked, and they would not
- 6 know unless you fashion an instruction.
- 7 So, yes, and yes. I don't know how better to
- 8 tell you. I am giving you what you are asking for.
- 9 MS. GUTIERREZ: Okay. I'll take it. Thanks,
- 10 Judge.
- 11 THE COURT: Well, you're welcome. Now, if we
- can have the jury come back in, we will continue with
- 13 this case. I know that the State may not agree but the
- 14 court's concern is that if this witness believes that he
- was engaged in a guilty plea and that, as a result of
- 16 that quilty plea, that this promise is binding in some
- 17 fashion and that is directing his testimony, the defense
- has a right to inquire as to the basis for that belief.
- 19 And if for some reason it is a faulty belief, then the
- jury is entitled to hear what it is that may have
- 21 happened during a guilty plea that this witness does not
- 22 either recall or may have forgotten or was not done, and
- 23 opens him up to a challenge to his credibility.
- 24 For that reason, I will allow the defense to
- 25 inquire.

MS. GUTIERREZ: Thank you, Your Honor. Since 1 2 the jury isn't here, but while we are waiting for them, I guess I would ask for the court's guidance. Obviously I 3 can't finish my cross of this witness today. 4 THE COURT: I know. 5 MS. GUTIERREZ: Are you still going to stop at 7 5:00? THE COURT: I am. 8 MS. GUTIERREZ: I will try to structure it so I 9 finish pieces together. 10 THE COURT: Right. 11 MS. GUTIERREZ: Okay. 12 THE COURT: I am going to stop at 5:00, and you 1.3 14 can piece it the way you would like to be the most cohesive. I know that we have to stop somewhere. 15 (Brief pause.) 16 17 (The jury returned to the courtroom.) THE COURT: All right. Ladies and gentlemen, 18 as you are finding your seat, we are going to proceed 19 with the testimony of Mr. Wilds. 20 , if you can ask Mr. Wilds to 21 return to the courtroom. 22

- subject to far more than five years, did you not?

- 15 THE COURT: Counsel, if you have other clients
- or other matters, I would be happy to work around your
- 17 schedule. But the defense, if they choose to call you,
- may call you in the defense. Well, you are still in the
- 19 State's case.
- 20 MS. BENAROYA: Yes.
- 21 THE COURT: So I can tell you that between now
- 22 and probably the middle of next week, you will probably
- 23 not be called. However, your client is still on the
- 24 witness stand and will remain on the witness stand on
- 25 Tuesday, that is starting Tuesday at 9:30.

- MS. BENAROYA: Yes, I'll be bringing him to
- 2 court.
- 3 THE COURT: So as a result of bringing him to
- 4 court, you may be served.
- 5 MS. BENAROYA: Yes, that's right.
- 6 THE COURT: And if you are served and it is
- 7 causing you some scheduling conflict with other cases or
- 8 proceedings, then I need to have you write me and
- 9 indicate what they are so that we can work around your
- 10 schedule.
- 11 MS. BENAROYA: Okay. That was all I needed to
- 12 know.
- 13 THE COURT: Fine. Any problem with that, Ms.
- 14 Gutierrez?
- MS. GUTIERREZ: No.
- 16 THE COURT: And Ms. Gutierrez has been kind
- 17 enough, and so has Mr. Urick, that at which time she has
- 18 determined that she does no longer need a witness, as you
- 19 have been hearing, we have been excusing witnesses and
- 20 releasing them from summonses as the case may be. So I
- 21 will ask that that happen, as you have done I think with
- 22 one of the doctors or police officers actually --
- MS. GUTIERREZ: Yes.
- 24 THE COURT: -- who indicated that he had a
- 25 conflict, and we worked around that as well.

1	MS. BENARUIA: Okay. Very good. Thank you.
2	THE COURT: All right.
3	MS. BENAROYA: That's all I needed.
4	THE COURT: Very well. Anything further?
5	(No response.)
6	THE COURT: Okay, Thank you.
7	(Counsel and the defendant returned to the
8	trial tables and the following ensued:)
9	THE COURT: Okay. Then Tuesday at 9:30. • Yes,
10	I see you are taking a deep breath. Is there a problem?
11	MR. URICK: Well, just so everyone is aware, I
12	have got a witness scheduled for Tuesday who is scheduled
13	to be out of town Wednesday, Thursday, and Friday. I
14	may, if Ms. Gutierrez goes into the afternoon, I may ask
15	to take him out of order and interrupt the cross-
16	examination and put him on so I can get him off.
17	MS. GUTIERREZ: Who is that witness?
18	MR. URICK: Abe I will get the
19	spelling to you later.
20	THE COURT: And I can give you a list of all
21	the witnesses from the voir dire.
22	COURT REPORTER: Thank you.
23	THE COURT: Okay.
24	MS. GUTIERREZ: Judge, I have no objection to

taking a witness out of turn. I do have an objection to

- interrupting Mr. Wilds' testimony again. You know, he is
- 2 the main witness.
- 3 THE COURT: Yes.
- 4 MS. GUTIERREZ: I don't know how long my cross
- 5 is going to take.
- THE COURT: I'm not going to limit your cross.
- 7 MS. GUTIERREZ: What I would suggest, what I
- 8 would be open to, is if on Tuesday morning if he would
- 9 rather put that witness on out of turn before we start
- 10 back with Mr. Wilds, I wouldn't object to that.
- MR. URICK: That would be fine.
- MS. GUTIERREZ: You know, so that we then don't
- interrupt Mr. Wilds a second time.
- 14 THE COURT: Obviously, if Ms. Gutierrez is
- 15 acquiescing to that procedure --
- MR. URICK: That's fine.
- 17 THE COURT: That's why I advised her of the
- 18 time, so that she could take her cross in chunks, which
- she has done. So if you would like to do that on Tuesday
- 20 morning, you can do that as well.
- 21 MR. URICK: Thank you.
- 22 THE COURT: All right. Anything else?
- 23 (No response.)
- 24 THE COURT: You all have a good weekend. I'll
- 25 see you on Tuesday.

1	MR. ORICK: Inank you, four honor.
2	THE COURT: But I will be back on Monday.
3	Staff, I will see you on Monday at 9:30. There is a
4	schedule of the hearings. You can check with my staff.
5	THE CLERK: I have the schedule, Your Honor.
6	THE COURT: You have got the schedule. Very
7	well. We stand in recess then until Monday at 9:30.
8	THE CLERK: All rise.
9	(Whereupon, at 5:20 p.m., the trial recessed.)
