Proof of current income in the form of salary or pay stubs for the last two pay periods.

4. If you are unemployed:

Proof of date of lay off or loss of job in the form of a letter from your last employer, or: Letter of certification from the unemployment office, or: A signed statement from the person supporting you, or: Proof of public assistance, medical assistance AFDC, Social Security

Proof of public assistance, medical assistance AFDC, Social Security or Supplemental Security Income (SSI) you are receiving.

The Office of the Public Defender accepts applications for representation weekdays from 8:30 a.m. to 4:30 p.m. Appointments are preferred, but not required.
